For all other citizens, a visa must be obtained prior to arrival in the United Arab Emirates. Other possibility is that once you have booked your hotel accommodation, your hotel can send you a visa application form and confirmation of the application processing fees. Please note that these fees are non-refundable. Please allow 7-10 working days in order to process a visa (note that Thursdays and Fridays are the public holidays in the UAE). To obtain your visa, you must provide the following documents: a clear photocopy of your passport, a visa form duly completed and signed, a photocopy of the front and back of a valid credit card, and travel insurance valid up to a minimum of 40 days from the date of arrival. Keep in mind that your passport must be valid at least six months beyond your intended stay.
