ACTIVITIES DURING 2007-2008 ACADEMIC YEAR

- 1. UAC Subcommittee on Admissions Reviews membership and terms of reference
 The composition and terms of reference for a newly created UAC Subcommittee on Admissions
 Reviews (see Appendix A) were proposed by UAC and approved by the Senate Nominating
 Committee. Subsequently, on a recommendation of the Nominating Committee, Senate approved
 the dissolution of the University Admissions Appeals Committee.
- 2. Desautels Faculty of Management supplemental application pilot for September 2008

 A pilot project was approved for admissions to the Bachelor of Commerce (B. Com.) program, to help identify applicants with qualities that may not be reflected in grades and, in some instances, may actually negatively affect an academic record, but which may be hallmarks of successful managers. Supplemental information, in the form of a personal statement, was added as a possible criterion for admissions to the B.Com program for CEGEP applicants who have borderline academic records.

3. Update on Côte de Rendement au Collégial (CRC)

CEGEP applicants for registration in September 2009 will present CRCs for each of their academic programs, rather than an overall CRC for their complete academic record. Program CRCs will benefit students who have changed programs after faltering in one and may benefit those who have completed a DEC in two programs. UAC decided to delay a discussion of how program CRCs will be used in admissions decisions at McGill until Fall 2010, after reviewing the results of 2009 registrants.

4. Joint FSL program – change in admission requirement

UAC approved revisions to the admissions requirements for the Joint Program in Education - Teaching French as a Second Language making them identical to those used by the Université de Montréal, effective for September 2008 admissions. At McGill, students applying to the program had to pass a language proficiency test before being admitted. At the Université de Montréal, students applying to the program were not required to meet this admission requirement but were required to take a diagnostic test and if they failed they had to take a mise-à-niveau course. In 2007-2007 three students were admitted, but thirty students might have been admitted if the proposed admission requirement was in effect.

5. New means to demonstrate English language proficiency

UAC approved revisions to the list of options (found at the following link: http://www.mcgill.ca/applying/undergrad2009-10/general-requirements/#xpgfld-203473) by which applicants can prove English proficiency to reduce unnecessary re-testing and to provide more options to applicants who are required to prove English proficiency. Additions include the Cambridge certificate of proficiency in English with a mark of 'B' or better and the London tests of English with a level 5 and a minimum of "pass" or level 4 with a minimum of "merit pass."

6. Earlier offers of undergraduate admission

UAC approved changes in admission criteria, enabling earlier admission decisions, which are needed to ensure that McGill remains competitive with other universities. For applicants presenting very strong academic records, offers of admission may now be made on the basis of Grade 11 course grades, where the usually required Grade 12 grades are not yet available. This may include Grade 11 results in prerequisite courses. Earlier offers of admission are expected to improve the yield (i.e., the percentage of offers that result in registrations) in our best pool of applicants for whom competition among universities is fiercest. The changes will affect applicants from high schools in British Columbia in 2009 and be extended to those from high school students in all provinces in Canada, except Quebec, in 2010.

7. Admission requirements – Continuing Education Graduate Certificate Accounting Practice UAC approved revisions to admission requirements for the Graduate Certificate in Accounting Practice (Department of Career and Management Studies) to enable a previously excluded group of qualified candidates to apply.

8. Faculty of Agricultural and Environmental Science admissions office move

The Faculty of Agricultural and Environmental Science admissions office was moved to join Enrolment Services at the downtown campus.

9. Faculty of Management admissions criteria change – MBA accelerated study option and CA-MBA program transition

An accelerated study option of the MBA program has been approved by UAC to attract prospective students with significant practical work experience. Such students are now exempt from the experiential component of the program, as they have the practical work experience required to complete the program successfully. The redesigned MBA is a 51-credit degree program, replacing the 60-credit current program. The students who enrol in the accelerated study option are exempt from the experiential component and may graduate with 45 credits.

At the same time, the CA program will also undergo some changes such as the addition of the 6-credit internship. Given the reduction of total credits in the MBA program, it is proposed that students who successfully complete the requirements of the CA program (full 30 credits, including internship) and who choose not to graduate and earn the Graduate Diploma in Public Accountancy may apply to the MBA program, and if admitted, may transfer 15 credits towards their MBA degree. Furthermore, the CA students will have already completed an internship and it was proposed that these students be admitted to the accelerated study option, thus are exempt from the 6-credit internship or practicum. As a result of the changes to both programs, a review of the option to transition CA credits to the MBA program was thought to be in order. Both proposals were approved by UAC on May 6th 2008.

SUBCOMMITTEE ON ADMISSIONS REVIEWS TERMS OF REFERENCE

- 1. The membership of the subcommittee shall be approved by the UAC every fall, and the subcommittee shall meet as required, with quorum comprising three members.
- 2. The subcommittee's mandate shall apply to both undergraduate and graduate students.
- 3. The subcommittee shall only review allegations that a unit's admission or review procedures were not properly followed. The subcommittee shall not reconsider the merits of individual admissions decisions. In the event that the Subcommittee deems a lapse in procedure has occurred, the admissions file shall be re-evaluated by the relevant unit. Members of the subcommittee shall recuse themselves where the review concerns an applicant for admission to a program in their faculty.
- 4. The subcommittee may, where necessary, make recommendations regarding procedures for faculty review of admissions decisions.
- 5. The subcommittee shall ensure that all admissions units have appropriate admission review procedures and that these procedures are clearly defined and easily accessible.
- 6. The subcommittee shall report annually to UAC.

SUBCOMMITTEE ON ADMISSIONS REVIEWS REPORT

1. Request for Review Process

The Subcommittee drafted a template setting out essential components of a statement about the request for a review process. The policy and procedure should consist of a definition of the purpose of the policy, a mention that review rarely leads to reconsideration of an application decision, a mention of the two possible reasons why a reconsideration might be allowed (i.e., established procedures for evaluation of applications were not followed; for reasons beyond the applicant's control, the admissions committee did not have all relevant documents when it made its decision), a description of the internal procedures and a mention that an applicant whose request for reconsideration has been turned down may refer the matter to the Subcommittee on Admissions Review.

The subcommittee also recommended to UAC that the Faculties of Medicine and Dentistry develop explicit admissions review procedures, the Schulich School of Music and the Faculty of Agricultural and Environmental Sciences formalize their existing procedures, and the Faculty of Religious Studies update and simplify its existing procedures.
