I hereby apply for a position as student clerk, for the next academic year, according to the conditions set out in the current Faculty syllabus and calendar. In filing this application, I undertake not to withdraw it. If selected, I will be enrolled by the Faculty for this 6-credit course from September through April of the 2017-2018 academic year, and I forego the right to withdraw from this course.

I understand that if for exceptional circumstances I wish to be considered only for a 3-credit student clerkship lasting for only one academic term, I must clearly specify this preference on this application form and provide carefully motivated reasons in the letter of application. I recognize that this selection may decrease my chances of being accepted by the Faculty and that there may be limited availability of student clerkships by the courts or administrative tribunals. If selected, I will be enrolled by the Faculty for this 3-credit course from September through December 2017 or January through April 2018, and I forego the right to withdraw from this course.

I understand that the Student Clerkship Programme involves a duty of confidentiality and a duty to avoid conflicts of interests or potential conflicts of interests, for example with law firms.

I undertake to make a total contribution of a minimum of 200 hours for a 6-credit clerkship or 100 hours for a 3-credit clerkship (approximately 8 hours per week), and to file a midterm report and a final report at the Student Affairs Office for the dates that will be posted by the Faculty.

I understand that my status will be that of an unpaid student intern participating in an educational program for academic credit evaluated on a pass-fail basis at McGill; I am not in an employment relationship.

I understand that the final selection of candidates, once accepted by the Faculty, is made by the courts or administrative tribunals.
