05.04 FACULTY OF AGRICULTURAL AND ENVIRONMENTAL SCIENCES – 01-SCTP-01-18

McGill School of Environment

B.Sc.; Major in Environment; Land Surface Processes and Environmental Change (60 cr.)

New program consists of 21 credits of Required Courses and 39 credits of Complementary Courses. In this new program, focus is on the integrative science of watershed system dynamics. Students will be introduced to the interacting physical and biogeochemical processes that fashion terrestrial and freshwater aquatic habitats, determine their biological productivity, their "usability" as support for human populations and their response to anthropogenic or natural environmental changes.

Professor Crago explained that last spring there was discussion with McGill School of Environment (MSE) representatives at APPC concerning how the MSE "domains" were integral to themselves and whether completion

of these programs would enable students to continue on to graduate studies. Professor Hendershot responded that

the MSE was currently undergoing a curriculum review, which may result in elimination of certain existing programs.

Professor Brawer commented that a wide variety of courses were offered, and queried if this variety would take away from the main topic, i.e., will it be recognized as a concentration in the field. Professor Crago stated that this had been discussed at length previously. The decision was made to wait and see what the outcome of the

graduating students would be. Professor Hendershot said that it is likely that students will enter into graduate studies based on their grades and not necessarily courses they have taken, and students interested in a field will concentrate on those courses and go into graduate studies in that area.

SCTP requested:

• curricular review report be forwarded to SCTP, which will in turn forward it to APPC. New program <u>approved</u> and it will be reported to APPC for approval.

Banner's Proposed New Course Proposal Form

The committee reviewed the revised course proposal form submitted by Ms. Cathy Workman, Banner SIS Team. The Chair commented that it was suggested at the SCTP Information Session that a graphic artist be hired to aid in the lay out of the proposal form; the committee agreed with this suggestion. The revised version has incorporated information pertinent for the new Banner system. The following suggested changes were made by committee members:

- have four separate proposal forms one for new courses, one for course revisions, one for new programs, and one for program revisions
- rewrite "Note" in box 10A
- be consistent with capitalization of letters following numbers (example: "10A", "33a")
- allow enough room for breakdown of hours to be indicated in box 12 and ask for total number of weeks
- too much space allowed for box 1 and not enough for box 17
- box 15 assumes that there is only one prerequisite, which is not always the case; item 2 in box 15 makes it a corequisite, so rewrite so that it reads: "Can prerequisite be taken as corequisite?"
- information requested in box 33a) was additional information SCTP wanted to avoid in description
- boxes 15 and 16 should also ask for title of prerequisites/corequisites
- boxes 18, 20, 21, 29, 30 do not require the parentheses
- remove "(e.g. 500 level courses)" from GQ in box 12A, as this is not correct
- retain from the current SCTP course proposal form the box that asks: "Will this course revision affect a current program? If yes, indicate here if a program change form has concurrently been submitted."
- have different font size/type in the space available in boxes for information to be completed

The SCTP Chair and Secretary will meet with Ms. Workman to discuss these suggested changes.
