This new option of the MSW; Non-Thesis consists of 24 credits of Required Courses and 21 credits of Complementary Courses. Dr. Crago commented that a BSW is the usual admission requirement for the MSW; Non-Thesis, but that is not the case for this program. Students will complete a qualifying period worth 9 credits, which would assist in improving students' English as well as learn basics of social work in the Canadian context.

Among the issues discussed, the following questions arose concerning this proposal.

- Will practice opportunities be available in all students' communities?
- Will graduates be qualified to be social workers in Canada?
- As professional accreditation is usually awarded to students with a BSW, what would the Canadian order accept

for accreditation with these students?

- What are the safe guards for students where their home community is a war zone and they are expected to complete a practicum?

- revise program rationale as follows: "Increasingly ... cohorts for graduate level <u>education</u> so that the cohorts have ..."

The revisions submitted were NOT approved and the School is requested to resubmit a revised proposal.

SCTP noted that the revisions are not appropriate for a program proposal, but rather an internal document presented to students by the School of Computer Science. Proposal submitted to SCTP should list descriptive paragraph and course (COMP 700) currently taken by students and in the revised column revisions to the descriptive paragraph and Required Courses changes [i.e., COMP 700 (title and credit weight) replaced by COMP 701 (title and credit weight)].

SCTP also noted that it is problematic that these procedures were posted on the School's Web site, since they contain very misleading information.

Dr. Crago indicated that she, as Dean of Graduate and Postdoctoral Studies, will arrange a meeting to discuss procedures with members of the School of Computer Science, since a number of the procedures are problematic as listed.

Some editorial comments:

- indicate program credit weight as "0 credits"
- revised programs are not to be placed on units' Web sites until they have obtained University approval
- Web site should be corrected to indicate "Six full-time terms ..."
- "Thesis oral defense" should read "Thesis oral defence"
- correct the following typo: "A student must ... Ph.D. Committeee."
- "At least two professors should be from the computer science department" should read: "At ... the School of Computer Science"
- last paragraph, delete the word "either"
