This new course will provide students, who have an undergraduate degree in another area, with the appropriate background

to prepare them to become clinicians. After completion of one of the new Master's-level programs proposed here, students may opt to complete the associated Graduate Diploma to obtain registered dietitian credentialing. In response to a query concerning the existing M.Sc.(Applied) program potentially being used as the credentialing program, Professor Gray-Donald reported that the enrolment for the existing M.Sc. program is increasing, but this is not the case for the M.Sc.(Applied) program; often, students enrolled in the

M.Sc.(Applied)

will switch into the M.Sc. program. It was queried whether it was important to name the two options this specifically, to which Professor Gray-Donald responded that it was done to better control the courses. The

added to the new options is restricted to students who are registered in a Master's-level program within the School of Dietetics and Human Nutrition. Students who have already completed a Master's program within the School, may take the course as a special student. When questioned, Professor Gray-Donald said that a separate diploma, which could be taken after a Master's degree, was a viable solution. SCTP thanked Professor Gray-Donald for attending this meeting.

M.Sc. in Human Nutrition; Registered Dietitian Credentialing (45 cr.)

This new program option was not approved. Instead, SCTP suggested the following:
