The goal would be to have three courses of this type under the subject code [one at 3, 6, and 9 credits] so student may take 3-18 credits. Ms. Hay indicated she will present at the next SCTP meeting of a break down of potential higher-level categories of courses, along with a template of the proposals that may be used.
