

Notes from an electronic review of reports submitted to the APPC Subcommittee on Courses and Teaching Programs (SCTP) held **Thursday, December 9, 2004**.

As there were a small amount of reports submitted for the December 9, 2004 SCTP meeting, the Chair decided to cancel the actual meeting and have an electronic review of documents distributed by the Secretary.

06.01 The Minutes of the meeting of November 25, 2004 were approved as circulated.

**CORRECTION:** The Minutes of November 11, 2004 were corrected as follows. Item 04.03, previously-submitted reports, Faculty of Education, New program **M.A. in Educational Psychology; Health Professions Education** (24 cr.) – program credit weight should have read “(48 cr.)”.

**NOTE:** The title for new course FINE 621 Restruc/Create Shareholder Value, which was approved at the SCTP meeting of November 11, 2004, was greater than 30 characters. Therefore the proposed title was shortened to “Restruc/Create Sharehldr Value”.

#### 06.03 **FACULTY OF MUSIC - 04-SCTP-12-17**

##### **Ph.D. in Music; Composition** (0 cr.)

New program proposal was withdrawn by SCTP. It did not need to be proposed as a new option but, rather, the Faculty of Music may advise students to take certain courses within the Ph.D. in Music program to focus on a particular area [example: composition]. As Ph.D. programs at McGill are not credit counting, the addition of courses will not affect the program's credit weight and a program revision to the current Ph.D. in Music is not necessary.

##### **L.Mus. in Jazz Performance; All Jazz Instruments and Jazz Voice** (100 cr.)

New program consists of 78 credits of Required Courses and 22 credits of Complementary Courses. It will offer students in jazz same opportunities as L.Mus. instrumentalist and vocalist students.
