Program Objectives

- Foster students' interest in research.
- Financially assist the best applicants in undertaking or continuing a Master's or doctoral program in disciplines related to the social sciences, humanities, arts and literature.
- The Fonds encourage students to lead and carry out transfer activities whenever relevant.

Committees are created to assess each applicant

Éducation, savoirs et compétences

(10A) Formation:

Formation continue; andragogie; formation professionnelle; formation des enseignants et enseignantes; formation en entreprise; orientation et counseling.

(10A) Pédagogie et approches éducatives :

Didactiques; enseignement des disciplines; alphabétisation; technologies éducationnelles; formation à distance; fondements de l'éducation; mesure et évaluation des apprentissages.

(10A) Systèmes d'éducation et de formation :

Éducation comparée; curriculum et programmes; gestion et administration de l'éducation ou de la formation; évaluation de politiques, des institutions et des programmes.

(10D) Éducation spécialisée :

Adaptation scolaire et sociale; psychopédagogie; orthopédagogie; psychoéducation.

Evaluation process Step 1: Ranking each applicant individually

- The committees are created into the Fall
- Distinction between Master and Doctorate
- Each member of the committee (usually 3 members /committee) receive all dossiers, including GPA coming from all Québec universities.
- Each member of the committee should read all of them and assess them in order to rank each applicant.
- In appareance of conflict of interest, the committee member doesn't assess the conflicting application.

For all master's and PhD awards, an evaluation committee will only recommend applications with a minimum total score of 60% (12/20).

Step 2: Creation of the ranking list

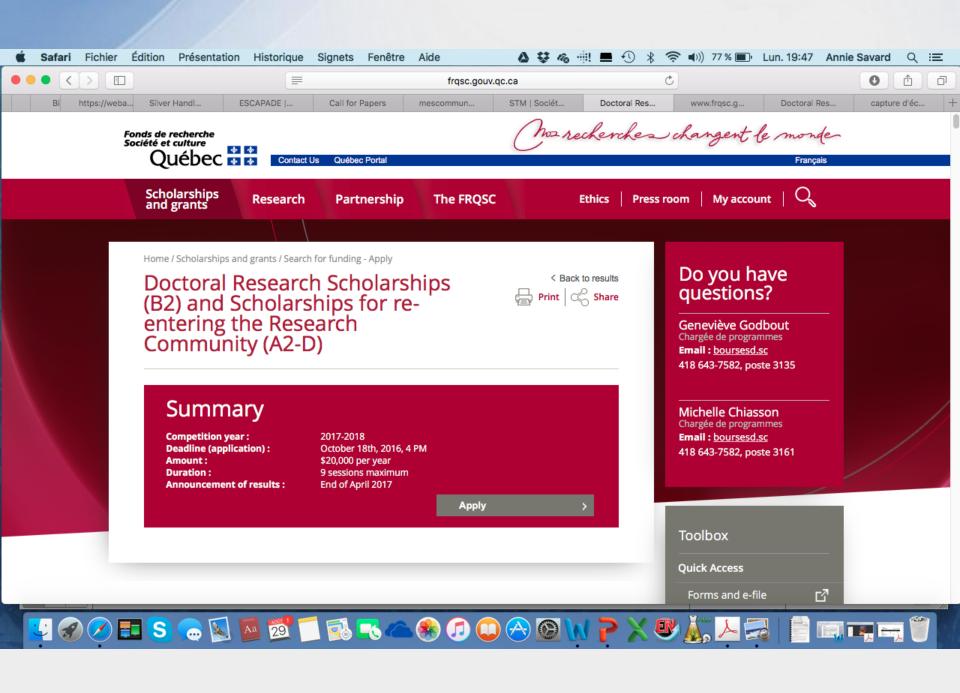
- Each committee member should compile his ranking for each aplicant, for each criteria.
- The Fonds Québécois de recherche comes up with a list with all committee members grades and a common one, using statistics.
- Consistency on the grading for each committee member.
- Some cases to discuss.

Step 3: Making final decisions

- The meeting are done using phone conference.
- The new ranking list appears on all computers through secured website.
- The discussion is about ranking: why this application is the 7th with this committee member and 3th with another one?
- The committee should agree on a new ranking list.

Concluding remarks

- You have to convince me that you are the best emerging researcher:
 - Clear and simple writing style;
 - Provide evidences of your talent;
 - Explain what it has to be explained;
 - Take it as a learning process: you will learn from this experience.
 - Stay confident: Who knows?
