REASONABLE CONSIDERATION REQUESTS:

- · Please note that Reasonable Consideration Requests are only valid if you received a notification from an Student Accessibility and Achievement-affiliated email.
- Reasonable Consideration Requests are valid for 1 semester only.
- Each semester, students with this support will submit a new Reasonable Consideration Request through Clockwork that will be sent to their course instructor by email.

STUDENT EXPECTATIONS

· Instructors use multiple modes of communication to share their pedagogical materials with students. Their slides, video recordings, lecture notes, etc. remain their intellectual property. As such, you may use these only for your own personal learning (and research, with proper referencing/citation) ends. Disseminating or sharing these materials may constitute a violation of the instructor's intellectual property rights and could be cause for disciplinary action under the Code of Student Conduct and Disciplinary Procedures.

PROFESSOR RECOMMENDATIONS

- Some students may need advanced access to lecture or course materials in order to access the materials (for example, using adaptive technology), or to have the materials adapted to an accessible format (e.g., Braille).
- As in all instances of students registered with Student Accessibility and Achievement, they are not required to disclose their diagnosis. If the student does disclose information regarding their disability, instructors should treat this information as strictly confidential.
- Instructors should remember that uploading lecture slides in advance and making them available for review afterwards can go a long way to support accessibility in the classroom, often reducing the need for certain individualized accommodations.
- · In the Remote Learning Environment, not all students will have access to the online platform during the usual class time for a variety of reasons. Providing slides, questions, exercises, and recorded lectures can help students participate at their own pace.
- In cases where lectures are not recorded, individual accommodations may be necessary for students who are unable to attend live lectures or other synchronous learning activities.
