DESCRIPTION OF HOST ORGANIZATION:	Founded and chaired by Nobel Laureate and former US Vice President Al Gore, The Climate Reality Project is dedicated to catalyzing a global solution to the climate crisis by making urgent action a necessity across every level of society.

REMUNERATION:	\$2,700 CAD issued through a Faculty of Arts Internship Award.

ELIGIBILITY:	<ul> <li>McGill Faculty of Arts students (B.A., B.A &amp; Sc., BSW, B.Th., M.A, MSW)</li> <li>Minimum CGPA of 2.7</li> <li>Returning to McGill in the fall semester following the internship</li> <li>Students must fulfill Faculty of Arts requirements as outlined in the Handbook for Interns <a href="https://www.mcgill.ca/arts-internships/resources">https://www.mcgill.ca/arts-internships/resources</a></li> <li>Proof of medical insurance for duration of internship</li> </ul>
COSTS:	The intern is responsible for all costs associated with the internship including transportation, accommodations, etc.
TRAVEL ARRANGEMENTS:	Preparing travel arrangements to and from the internship host organization is the responsibility of the intern.
ACCOMMODATION:	Finding suitable lodging during the internship is the responsibility of the intern.
ENTRY REQUIREMENTS:	Interns are responsible for informing themselves of what entry requirements are required to visit and work as an intern in the internship host country. These may include a visa, work permit, passport valid for at least 6 months after entry, and proof of certain vaccinations.  The intern is responsible for acquiring all necessary documents in time for the beginning
