POSITION:	Intern – Community Climate Hubs
LOCATION:	In-person: Montreal, QC - intern is expected to intern at the host organization office location. <u>OR</u> Remote: The internship is conducted 100% remotely.

DESCRIPTION OF HOST ORGANIZATION:	Established in 2007 as a charitable organization, The Climate Reality Project Canada's (CRPC) mission is to build and connect networks of empowered individuals in communities across Canada by equipping them with the tools and knowledge to bring about new behaviours and policies that lead to a low-carbon, resilient, and just future. To achieve this, we build, maintain, connect and empower local, pan-Canadian and worldwide networks of Climate Reality Leaders (CRLs) and other advocates who will accelerate change and its social acceptability, and who will collectively raise ambition in the fight against climate change through impactful programs and partnerships. By empowering Canadians in their advocacy and increasing public policy literacy, we work to ensure that all citizens feel compelled and equipped to take part in the democratic decision-making process and become effective catalysts for change in their network of influence.
	policy and solution literacy: people who not only make climate-sound decisions in their day-to-day, but who spread climate awareness and empathy, and lead their communities towards better practices of sustainability and justice as citizens, consumers, voters, and compassionate members of society more generally. In other words, we are creating a critical mass of citizens who are not only well-informed on the science and solutions to climate change, but are equipped with the tools, networks, programs, and opportunities to advance concrete solutions to overcoming the crisis. 	<b>Community Climate Hubs</b> Launched in 2017, the Community Climate Hubs program focuses on the local level, where risks of a changing climate (floods, heatwaves, etc.) and rewards of reducing pollution (air quality, cost savings, etc.) are most tangible. We support citizen-led, grassroots organizing at the local level, in the form of Community Climate Hubs, pushing folks to raise the climate ambition in their municipalities across the country. The Community Climate Hubs program delivers support and structure to grassroots groups that may not be as easily available to them, notably due to capacity reasons. The Climate Reality Project Canada provides invaluable administrative support and the creation of quality resources so that people with boots on the ground can focus on what's important: pushing the climate movement forward with their campaigns. By connecting and supporting 20-30 Hubs across the country, the program offers a unique bird's-eye-view knowledge of what is happening locally across the country, everywhere from small towns to major cities. This knowledge is used and shared across the network, allowing connections to be made between people and Hubs doing similar work as one another, connecting experts in areas on which Hubs are working, and having fast access to the latest resources and organizational prowess.

Begin to create outreach plans with them.</li> <li>Create easy to follow guides or templates that help Hubs learn basics in social media, website design, newsletters, etc.</li> </ul>

HOURS:	Part time (15 hours per week), flexible schedule, generally between 9am - 6 pm EST, Monday to Thursday.

COSTS:	The intern is responsible for all costs associated with the internship including transportation, accommodations, etc.
TRAVEL REQUIREMENTS:	<u>Pre-Departure Orientation</u> is mandatory for students applying to internships that require travel outside of Canada. You will be required to download the certificate of completion in your application.
TRAVEL ARRANGEMENTS:	Preparing travel arrangements to and from the internship host organization is the responsibility of the intern.
ACCOMMODATIONS:	Finding suitable lodging during the internship is the responsibility of the intern.
ENTRY REQUIREMENTS:	Interns are responsible for informing themselves of what entry requirements are required to visit and work as an intern in the internship host country. These may include a visa, work permit, passport valid for at least 6 months after entry, and proof of certain vaccinations. <u>The intern is responsible for acquiring all necessary documents in time for the beginning of their internship.</u>
