Board of Governors meeting of April 21, 2016

The following report arises from the Senate meeting held on March 23, 2016. It contains items which are presented to the Board of Governors for consideration.

I. FOR ACTION BY THE BOARD OF GOVERNORS

1. 471st Report of the Academic Policy Committee (APC)

1.1 Statement of Academic Freedom

Senate reviewed the Academic Policy Committee's proposal for a Statement of Academic Freedom and recommended that it be approved by the Board of Governors.

In 2011, the McGill Association of University Teachers (MAUT) established an *ad hoc* Committee on Academic Freedom to develop a university statement on academic freedom. The committee had wide consultations with members of the McGill community, including MUNACA, MUNASA, SEIU, SSMU, and PGSS. The committee then developed a statement that was adopted by MAUT Council, and by the MAUT membership. The proposed Statement of Academic Freedom affirms and embraces the key principles found in the McGill University Mission Statement.

Be it resolved that the Board of Governors, on the recommendation of Senate, approve the proposed Statement of Academic Freedom, as presented in Appendix A.

2. Report of the Senate Nominating Committee:

2.1 Appointments to the University Appeals Committee

Senate approved recommendations to University committees, as recommended by the Senate Nominating Committee. Senate's recommendations concerning appointments to the University Appeals Committee are submitted for approval to the Board of Governors in accordance with university regulations.

Be it resolved that the Board of Governors, on the recommendation of Senate, approve the appointments of Professors Robert Leckey (LAW) and Andrew Kirk (Electrical and Computer Engineering, ENGINEERING) as members of the University Appeals Committee, for three-year terms beginning September 1, 2016 and ending August 31, 2019.

1. 471st Report of the Academic Policy Committee (APC)

The policy was approved on February 16, 2011 and last amended on January 23, 2013. A number of sections of the policy were revised to ensure a fairer and clearer assessment environment for students.

Senate received this report for information. It provided an overview of the University's enrolment statistics for the Fall 2015 enrolment cycle and of the implementation of the University's strategic enrolment management plan.

Statement of Academic Freedom

September 9, 2015 [revised February 25, 2016]

Academic freedom is central to McGill University's mission of advancing learning through teaching, scholarship and service to society.

The scholarly members of the university have the freedom to pursue research and artistic creation and to disseminate their results, without being constrained by political or disciplinary orthodoxies, monetary incentives or punitive measures as a result of their academic pursuits. They may exercise this freedom in the service of both the university and the wider society. When scholarly members of the university participate in public forums and debates, they should represent their views as their own.

The exercise of academic freedom requires collegial governance with the full participation of scholarly members. They retain the right of free expression, including the freedom to criticize one another, university policies and administration.

The university and its officers have a duty to protect the academic freedom of its scholarly community, both individually and collectively, from infringement and undue external influence as well as to maintain the university's institutional autonomy.
