OBJECTIVES

NATURE OF THE COMPETITION

The participants must take a position on one of the proposed topics; that is it they must answer by the affirmative or the negative to the question asked. The choice of question and position taken must be stipulated in the registration form in order for the YBAM to determine the order of presentation of the candidates.

The public is welcome to attend the competition. A member of the Young Bar Association of Montreal will briefly present the participant, the topic chosen and the position taken which will be pleaded by the participant by the affirmative or the negative.

The participant's presentation <u>may not exceed 8 minutes</u> and cannot be interrupted by the members of the jury.

Following the participant's presentation, each member of the jury will have a chance to offer their comments regarding the participant's performance as well as ask the participant questions relative to the presentation.

Immediately following all presentations, the jury will convene to decide the winner of the **Air Canada** English Oratory Competition 2008, whose name will be announced during the award ceremony to be held at the cocktail party that will take place immediately following the competition, at Mélë Bar.

EVALUATION

The following criteria will be evaluated by the jury: command of the English language, general culture, originality, humour, ease, personality, charisma, communication abilities and general impression.

FIRST PRIZE
