### PROTECTION OF PERSONAL INFORMATION

**BILL 65:** The Act Respecting Access to Information Held by Public Bodies and the Protection of Personal Information.

Personal information is protected by legislation in the Province of Quebec. The provisions of this statute are such that discussion about a student's application file, or access to that file, is restricted to the applicant involved. Other persons or organisations can have access to information pertaining to a student's application only if the student has provided the Centre for Continuing Education with written authorisation which specifies both to whom information can be given and the type of information which can be released.

Certain information gathered by the University about an applicant or student will be released to the following bodies upon their request:

- a) the Student Association recognised by McGill University;
- b) the McGill Alumni Association;
- c) the school(s) or college(s) which the student attended;
- d) the appropriate authorities involved with the external or internal funding of fees;
- e) the professional bodies or corporations (e.g. engineers, dentists).

A student may oppose the release of information to those named above by completing an Opposition Form at the Admissions, Recruitment and Registrar's Office.

Officers and members of the University staff (e.g. Faculty officers, Office of the Dean of Students, etc.) may also have access to relevant parts of such records for recognised and legitimate use.
