

Trans Youth and Families Journal Watch



Research Seminar - GlobalChild: A rights-based approach to child health and development in Canada and beyond by Ziba Vaghri, University of Victoria

The United Nations Convention on the Rights of the Child (CRC) is the main human rights treaty providing international standards, but also accountability, for the fulfillment of children's rights. The Convention stipulates a monitoring system for all 195 countries that have ratified the CRC and places the international obligation on countries to write periodic reports to the Committee on the Rights of the Child (the Committee, hereafter) as the monitoring body of the Convention every 5 years.

Reporting on CRC remains a challenge for most of the countries. For example, in Canada, despite our leading role in the development of the CRC and its early ratification, our reporting has been unsatisfactory. The Committee has indicated that we need to "...strengthen and centralize mechanisms to compile and analyze systematically disaggregated data ...". Additionally, Canada's reports are not submitted in a timely manner and its last report was reviewed over a decade after the previous one. This project proposes to address these issues by creating GlobalChild (GC), a comprehensive tool to facilitate CRC monitoring and implementation by the use of indicators.



GlobalChild builds upon the expertise of a large team of national and international experts. It is founded on a decade of work with the UN Committee, and will continue to be conducted under the auspices of the UN Committee.

During this presentation, an overview of a decade of work with the UN agencies, such as WHO's global crusade of the Commission on Social Determinants of Health (CSDH), which has led to the development of the idea of GlobalChild will be presented. The international team

undertaking this project will be introduced and the characteristics of GlobalChild as a comprehensive child rights monitoring platform and its role in enhancing our accountability to children will be discussed. Canadian Children’s Charter

[Children First Canada](#), in partnership with Wisdom2Action, have launched a project to create a *Canadian Children’s Charter* – a vision and a plan of action to make Canada the best place in the world for kids to grow up.

You are invited to support children and youth from all across Canada to create the *Canadian Children’s Charter*. You can get involved in three ways:

1. Host a Focus Group – Lead a discussion with children and youth (under 18 years old) to share their insights on the critical issues facing them and their friends, and to identify opportunities for action at a local and national level. This is an important way of reaching young people with less access to Internet, as well as providing an opportunity for groups of young people to collectively consider their rights.
2. Complete the Online Survey – Invite the children and youth you know to contribute their ideas to the Canadian Children’s Charter through a national survey. Participants will be eligible to enter a draw for prizes.
3. Nominate Children and Youth for the National Summit – Young people from across Canada will gather on November 21 and 22 in Ottawa to consider the views from other young people from across the country, as well as connect with other young leaders, leaders of children’s charities, corporations, government and the media. This will be a highly participatory experience that will see young people finalizing and presenting the Children’s Charter, as well as gain valuable experience in community engagement, public speaking, and facilitation.
