A student will not receive confirmation of admission to the PhD in Oral Health Sciences program until a commitment of financial support is obtained from (a) a supervisor willing to financially support the student, or (b) has a scholarship from an external agency (e.g CIHR; RSBO; FRQ, etc), or (c) a sponsorship from a foreign governmental, institution, or private dental center. The funding source, duration and amount must be clearly stated as a prerequisite for admission review and consideration.

As of Fall 2023, the annual stipend is as follows:

For an International Doctoral Student: The minimum stipend offered by our faculty is \$37,000 for the first year, then a minimum of \$32,000 for the second, and a minimum of \$32,000 for the third year.

For a Canadian/ Permanent Resident Doctoral Student: The minimum stipend offered by our faculty is is \$24,000 per year, for 3 years.

(Note: From the minimum stipends indicated above, the supervisor is contributing a minimum of \$15,000 for Year 1, \$17,000 for Year 2, and \$17,000 for Year 3, and the balance is paid by the faculty for international PhD students. For domestic PhD students, for year 1, 2, 3 the supervisor is responsible for a minimum of \$10,000, \$12,000, \$12,000, respectively, and the balance is paid by the faculty.) The supervisor's contribution may vary if the student receives additional external or internal funding. Supervisors are reminded that a top-up is important if the student total financial package is too little for tuition and living expenses.

Please note that supervisors are encouraged to pay more than the minimum stipend recommended above or to guarantee a longer period of support (such as 4 years), if they can afford. Stipend amount is paid annually on the condition that the student has progressed satisfactorily. All students are required to apply for at least one federal or provincial award each year they are eligible in order to receive faculty funding. The annual cost of living in Montreal is ~ \$20,000/yr. Tuition and fees cost: see here
