Course Description

Third Level Chinese is an intermediate Chinese language course designed to satisfy the interest of students who wish to continue their learning of Chinese following their completion of McGill's EAST 230D and EAST 330D or equivalent courses from other institutions.

Along with other pedagogical methods, this course attempts to employ a more communicative approach for students to engage in a more meaningful and interactive learning experience. At the core of this approach is the idea of learning the target language by using it in an authentic context to introduce, express and describe orally as well as in writing.

Development of the four skills (listening, speaking, reading, and writing) will be equally emphasized in this course. To achieve this goal, the class will go beyond the textbooks and try to sample selected materials from various Chinese sources. These may include news stories, journal articles, and passage of literary works, which have appeared either in original Chinese media or have been selected and used in some Chinese textbooks. In addition, some audio/video materials reflecting real life situations from the internet will also be selected, and all these will be used to serve as the very basis for our reading comprehension and oral discussions. Students

are strongly encouraged to prepare ahead of class meetings each time and actively participate in class discussions and learning activities.

Learning Outcomes

By the end of this course students are expected to master a few more hundreds of authentic Chinese expressions, including commonly used proverbs, idiomatic phrases, as well as some most useful grammatical devices and syntactical patterns for a relatively coherent expressions of ideas and smooth narrations in better organized structures. In addition to further development of handwriting skills in Chinese, you will also learn to use computer to type Chinese characters and AI tools such as ChatGPT to read authentic Chinese passages and write Chinese composition.

Mode of Course Delivery

Class meetings are held mostly in-person, for Mondays and Wednesdays, with lectures, discussions, and interactive activities in classroom settings. However, Fridays will be reserved for students to work independently on written and oral-listening assignments, and/or group activities or special events such as group visit to Chinatown, participation in local Chinese cultural activities, celebration of Chinese festivals, Chinese calligraphy and arts exhibitions.

Besides the required textbooks and workbooks, electronic platforms such as myCourses, Learning Branch, as well as some relevant internet recourses and tools will be used for course management, course material delivery, discussions and practice, as well as class-related announcements.

In addition to the required textbooks, other course material will be selected by the instructor and to be used for the purpose of enhancing students' proficiency level in understanding authentic Chinese speeches and texts. In this way the students can learn the language in a more meaningful way.

Importance of Class Attendance:

Class attendance and active participation in this course are extremely important and mandatory. We will take attendance **10** times during each semester. Students are allowed to be absent **twice** during those 10 times each semester. Absence of more than two class meetings during the dates checked, **that is not backed up by medical documentation**, will result in 1% grade reduction of the final total grade for every missed session. Please note, you should not email to inform the instructor of your intended or planned class absence, as such email notice will not be accepted as an excused and acceptable absence.

The lectures are not to be recorded. Therefore, in case you have missed a lecture/class, you may check with fellow students to share notes with you, and it is encouraged that students help each other and foster a friendly and positive learning community either in person or online, such as in myCourses – Discussion, where discussion groups will be created.

Methods of Evaluation:

Late Assignment and Missing Quizzes

No extensions will be given for assignments. Late assignments are subject to a penalty of 1% per day for each submission, up to a total grade reduction of 10% in your final grade, calculation of the number of days of delay include weekends. No

assignments are accepted after one week past the due date. Exceptions are only made in extraordinary circumstances (illness, family emergency), if arrangements are made in advance of the due date, and appropriate documentation (e.g., a medical note or a funeral notice) is provided to the instructor.

No makeup quizzes will be granted, except for acceptable reasons such as serious illness, and such claim must be supported by proper documentation such as a letter from your doctor.

Requests for Reread

Appeals or requests for a re-read of written assignments, quizzes and exams must be made within one week after the graded materials have been returned or otherwise made available for the students to view.
