Course Description: This course provides a practical experience. Students will develop and understand how to perform and apply the basics of gymnastics and dance to the Quebec Curriculum while developing the professional competencies required for teacher certification.

Students will also be introduced to the Quebec education program (QEP), with emphasis placed on the following competencies

- **Competency 1 (Demonstrates movements in different physical activity settings)**
- **Competency 2 (Interacts with others in different physical activity settings)**

Learning outcomes

- Students will be able to integrate a variety of skills and movements into a short routine
- Students will be able to link artistic and rhythmic movements together aesthetically
- Students will be able to adjust skills depending on ability
- Students will be able to identify learning cues for multiple skills
- Students will be able to spot a variety of movements

Course format: be delivered in person, students are responsible for attending their registered section.

Instructional methods:

Assignments which build in complexity

Group projects which reinforce learning developed throughout semester.

Attendance policy:

In order to better equip students with the professional behaviours required as a teacher, the following must be respected. Student may miss a total of 270 mins of class. At the start of each class you are expected to sign the attendance sheet. If you miss the sign in and I cannot verify your attendance it will automatically be considered a missed class. Due to The frequent absences in the past, the following will apply to peer teaching. "Unless excused by a valid doctors note or a signed attestation by a varsity coach for an exterior competition, ANY student absent from class during peer teaching will lose 5% from their peer teaching grade. Tow absences during this time will result in a 10% lose etc..."

Once you have submitted an assignment, it will be considered a final submission. No additional submissions will be accepted. Assignments should be submitted at the specified time or a 5% penalty per day will be applied. Students having difficulty completing assignments should notify the instructor prior to the submission date. If an assignment is late and surpass 3 days, it will be considered as ZERO.
