Dr. Deneen Vojta brings experience as an entrepreneur, and strategic leader in the healthcare industry. She has a successful track record of accelerating the design, execution and scaling of disruptive programs, products and services and has built multiple businesses with successful exits. Dr. Vojta joined UnitedHealth Group in 2006 after the company acquired MYnetico, a digital disease management company that she founded and served as CEO. Dr. Vojta began her career at The Children's Hospital of Philadelphia (CHOP) where she was a resident in Pediatrics and a fellow in Hematology & Oncology. Subsequently, she launched a CHOP's pediatric hospitalist program. Currently, Dr. Vojta serves on the governance board of Childrens' Minnesota and the

advisory board of The Center for Health Incentives & Behavioral Economics at Penn Medicine. In 2014, she was an Emmy ® Award winner and in 2013, a CES ® Innovation Design and Engineering Innovation Honoree. Dr. Vojta holds a M.D. from Temple University School of Medicine, and a B.S. in Behavioral Neuroscience from University of Pittsburgh.
