Audit No. – Reference number assigned to the Advance or Reimbursement transaction in Minerva. Used to reconcile within the Finance system as the Vendor Invoice number

Finance Document Number – e.g. IE123456

Banner Feed Date – Date the transaction loaded to Banner

Paid To – Individual paid on the request

Responsible McGill Person – Individual responsible for the request

Additional Information – Includes amounts, dates, destination city, purpose & FOAPAL(s)

Amount fields are:

FOAPAL Amount – Amount charged to FOAPAL per item

GST Amount – GST amounts charged to FOAPAL per item

QST Amount – QST amounts charged to FOAPAL per item

Total for Amount – Total of Advance or Expense Reimbursement request

Grand Total – Sum of all Advance and Expense Reimbursements listed
