Masters of Urban Planning (M.U.P.) (Non-Thesis): Urban Design (66 credits)

The existing concentration "Urban Design" is renamed "Urban Development and Urban Design" to reflect contemporary needs and to integrate two new faculty members. Replacement of course URBD 602 – Issues in Urban Design with URBP 551 – Urban Design and Planning. Removed complementary courses (ARCH 520 – Montreal: Urban Morphology, ARCH 527 – Civic Design, ARCH 561 – Affordable Housing Seminar 1, ARCH 562 – Innovative Homes and Communities, ARCH 528 – History of Housing, ARCH 529 – Housing Theory, ARCH 550 – Urban Planning and Development, URBP 505 – Geographic Information Systems, URBP 607 – Reading Course: Urban Planning). New complementary courses added (URBP 553 – Urban Governance,

Faculty of Medicine

Masters of Science (M.Sc.) in Public Health (Non-Thesis): Global Health (60 credits)

Increased the credit weight of required courses from 32 to 33 credits. Increased the credit weight of the following required courses from 0.5 to 1 credit: PPHS 629D1 – MScPH Forum 1, PPHS 629D2 MScPH Forum 1. Decreased the credit weight of complementary courses from 19 to 18 credits, with 12 credits of coursework required at the 500 level or higher.

Masters of Science (M.Sc.) in Public Health (Non-Thesis): Population Dynamics (60 credits)

Increased the credit weight of the following required courses from 0.5 to 1 credit: PPHS 629D1 – MScPH Forum 1, PPHS 629D2 MScPH Forum 1. Decreased the credit weight of complementary courses from 16 to 15 credits, with 12 credits of coursework to be taken at the 500 level or higher.

Masters of Science (M. Sc.) in Public Health (Non-Thesis): (60 credits)

Increased the credit weight of required courses from 29 to 30 credits. Increased the credit weight of the following required courses from 0.5 to 1 credit: PPHS 629D1 – MScPH Forum 1, PPHS 629D2 MScPH Forum 1. The increased credit for PPHS 629 will be transferred from elective credits and will reflect the introduction of new concepts related to the practicum/project.

The following approved programs revisions were submitted to ES on October 12th

Interfaculty Studies (IFS)

Master of Engineering (M. Eng.) in Biological and Biomedical Engineering (Thesis) (45 credits)

Created new course – BIEN 590 to be added to the list of quantitative courses. Created a new course BBME 600 N1/N2 to accommodate students starting in the Winter term. This course will be added to the required courses. Students can take either BBME 600D1/D2 or BBME 600 N1/N2 (same day/time slot). Created new courses in BME (BMDE 625 D1/D2 and BMDE 654) to be added to list of complementary courses, which can count as part of the 12 credits of core courses from BIEN, or BMDE courses. Created new courses in BME (BMDE 653 and BMDE 655) to be added to list of 6 credits of elective courses and added more courses to the list of electives.

Faculty of Medicine

Master of Science Applied (M.Sc.A.) in Occupational Therapy – Non-Thesis (62 cr.)

Increased the credit weight of required courses: OCC1 503 – Clinical Practicum 3, and OCC1 623 – Assistive Technology by one credit to reflect proper course workload.

Master of Science Applied (M.Sc.A.) in Physical Therapy - Non-Thesis (62 cr.)

Increased the credit weight by one credit of these required courses: PHTH 573 – Clinical Practicum 3 to reflect the number of weeks in clinical practicum, which is 8 weeks long (full-time); and PHTH 622 – Pain Management to align with the content of the Canadian Pain Guidelines.

Schulich School of Music

Master of Music (M. Mus.) in Performance; Conducting (Thesis) (45 credits)

Revisions made to prerequisite courses, removed or replaced existing courses, and created three new Conducting Tutorial courses to reflect the best pedagogical practices for conductors.

Master of Arts (M.A.) in Communication Studies (Non-Thesis) (45 credits)

This program is no longer supported and its retirement is requested.
