Decreased program credit weight from 48 to 45 credits in order to meet Quebec Ministry-mandated revision of programs in excess of 45 credits.

Master of Arts (M.A.) German (Thesis) (48 credits)

Decreased program credit weight from 48 to 45 credits in order to meet Quebec Ministry-mandated revision of programs in excess of 45 credits.

Master of Arts (M.A.) Hispanic Studies (Thesis) (48 credits)

Decreased program credit weight from 48 to 45 credits in order to meet Quebec Ministry-mandated revision of programs in excess of 45 credits.

Faculty of Medicine and Health Sciences:**Master of Science, Applied (M.Sc.A.) Communication Sciences & Disorders (Non-Thesis): Speech-Language Pathology (82 credits)**

Increased credit weight of Required Courses from 79 to 82 credits. Removed Complementary Courses section (3 credits). Revised credit weight of some courses to accurately reflect workload. Removed and added courses to address content needed for accreditation and/or the development of clinical skills in a competency-based training framework. Revised course activities and titles of some courses. Revised program description.

Master of Science, Applied (M.Sc.A.) Nursing (Non-Thesis): Mental Health Nurse Practitioner (45 credits)

Removed Required Courses NUR2 691 (3 credits), NUR2 692 (4 credits) and NUR2 693 (4 credits). Added Required Course NUR2 655 (12 credits). Decreased credit weight of NUR2 694 from 4 to 3 credits. Revised program description.

Graduate Certificate (Gr. Cert.) Theory in Mental Health (15 credits)

Revised program title. Increased program credit weight from 15 to 21 credits. Removed Required Courses NUR2 692 (4 credits) and NUR2 693 (4 credits). Added Required Course NUR2 655 (12 credits). Decreased credit weight of NUR2 694 from 4 to 3 credits. Revised program description.

Graduate Diploma (Gr. Dip.) Mental Health Nurse Practitioner (30 credits)

Removed Required Courses NUR2 655 (8 credits), NUR2 695 (4 credits) and NUR2 696 (4 credits). Added Required Courses NUR2 691 (6 credits), NUR2 692 (6 credits) and NUR2 693 (6 credits). Decreased credit weight of NUR2 656 from 14 to 12 credits. Revised program description.

Graduate Diploma (Grad. Dip.) Oncology (30 credits)

Added ONCO 635 (3 credits) to list of Complementary Courses. Added sentence to the 6-credit course grouping in Complementary Courses section. Revised title of FMED 505 (3 credits).
