Department members are in consensus that the language requirement does not provide significant 'added value' for our doctoral students in terms of their skill repertoire. Rather, it slows them down in terms of academic progress and, we believe, serves as a distraction from pursuits (e.g., writing articles, gaining further methodological training) that would offer a greater payoff in terms of the job market. In some instances, we readily concede, knowledge of another language is requisite for research purposes; and, we would encourage language training in such cases. This is the scenario for a very small minority of our students, however; not the majority. We follow the trajectory of many other sociology PhD programs, in North America, in terms of this shifting of pedagogical tactics. This language requirement removal will apply retroactively to students who were already enrolled in the program.</p> </div>
