Section A – Graduate Programs

Minor/Moderate Graduate Program Revisions

Faculty of Arts

Master of Arts (M.A.) in Linguistics – NT (45 cr.) – Phonetics is a more central part of the program so now there is additional required course – LING 630 Phonetics (3 cr.). Two complementary courses that no longer fulfill a requirement were removed – LING 530 – Acoustic Phonetics (3 cr.) and LING 619 – Experimental Foundations (3 cr.).

Ph.D. in Linguistics (0 cr.) – Phonetics is a more central part of the program so one required course LING 619 – Experimental Foundations (3 cr.) has been removed and replaced with two additional required courses – LING 630 Phonetics (3 cr.) and LING 635 – Phonetics and Phonology 4 (3 cr.). Removed most of the courses listed under complementary courses.

Faculty of Law

Joint M.B.A. with B.C.L., LL.B. (144 cr.) – The graduate component (M.B.A.) of this joint degree has not been revised but CGPS approval is required (revisions made to the undergraduate components only).

Joint M.S.W. with B.C.L., LL.B. (132 cr.) – The graduate component (M.S.W.) of this joint degree has not been revised but CGPS approval is required (revisions made to the undergraduate components only).

Faculty of Medicine

Master of Science (M.Sc.) in Microbiology & Immunology – Thesis (45 cr.) – Added MIMM 607 – Biochemical Pathology (3 cr.) and added the sentence “Any life sciences-related 500-level or above course (3) – Departmental approval required.” to the complementary list.

Ph.D. in Microbiology & Immunology (0 cr.) – Added MIMM 607 – Biochemical Pathology (3 cr.) and added the sentence “Any life sciences-related 500-level or above course (3) – Departmental approval required.” to the complementary list.

Master of Science Applied (M.Sc.A.) in Occupational Therapy (58 cr.) – Added OCCI 600 – Clinical Practicum Seminars (0 cr.) to the required courses.

Faculty of Music

Master of Music (M.Mus.) in Jazz Performance – Thesis (45 cr.) – Added MUPG 695 – Graduate Jazz Improvisation Seminar (3 cr.) as a required course.

Section B – Graduate Program Retirements

Graduate Diploma in Library and Information Studies (30 cr.) – Research students now enroll in the PhD program, and the Graduate Diploma is no longer needed.
