Minor/Moderate Graduate Program Revisions

Faculty of Education

Master of Arts (M.A.) in Teaching and Learning — Science and Technology Option (60 cr.) – Two 1-credit seminar courses are being merged into a single 2-credit seminar to ensure the development and integration of major projects throughout the program.

Master of Arts (M.A.) in Teaching and Learning — Social Sciences Option (60 cr.) – Two 1-credit seminar courses are being merged into a single 2-credit seminar to ensure the development and integration of major projects throughout the program.

Master of Arts (M.A.) in Teaching and Learning — Mathematics Option (60 cr.) – Two 1-credit seminar courses are being merged into a single 2-credit seminar to ensure the development and integration of major projects throughout the program.

Master of Arts (M.A.) in Teaching and Learning — English Language Arts Option (60 cr.) – Two 1-credit seminar courses are being merged into a single 2-credit seminar to ensure the development and integration of major projects throughout the program.

Master of Arts (M.A.) in Teaching and Learning — English Or French Second Language (60 cr.) – Two 1-credit seminar courses are being merged into a single 2-credit seminar to ensure the development and integration of major projects throughout the program.

M.A. Education and Society - NT (45 cr.) – The program is being revised to replace 24 credits of electives with 24 credits of complementary courses to provide greater focus to the program.

M.A. Education and Society – NT – Gender and Women's Studies (45 cr.) – The option is being revised to remove streams in complementary courses, which will simplify the structure.

M.A. Educational Leadership – NT - Coursework (45 cr.) – The program revision moves one of two research methods courses to the complementary course list since students are not required to do a research project.

Ph.D. Educational Studies - Language Acquisition (0 cr.) – The revision to this option reduces the number of required courses.

Master of Business Administration – **NT** – **Finance** (57 cr.) – This option is being revised to include up to 3 credits from select cross-disciplinary courses.

Master of Business Administration – NT – Global Strategy and Leadership (57 cr.) - This option is being revised to include up to 3 credits from select cross-disciplinary courses.

Master of Business Administration – NT – Marketing (57 cr.) – This option is being revised to ensure students take one of two courses in the complementary course list. This option is also being revised to include up to 3 credits from select cross-disciplinary courses.

Master of Business Administration – NT – Technology and Innovation Management (57 cr.) – This option is being revised to include up to 3 credits from select cross-disciplinary courses.
