New Programs:

a) Graduate Certificate in Information Architecture and Design

CGPS.14.36-GradCert_InfoStud _InfoArchDesign

CGPS.14.43 - MinMay11_15

Dean Kreiswirth invited Professor France Bouthillier to present the Graduate Certificate in Information Architecture and Design and respond to any questions from members of Council.

There is a growing demand for information professionals in the area of information architecture and design. The Graduate Certificate in Information Architecture and Design would attract students who do not want to do a full Master's program and who have finished a bachelor in any discipline and/or those who have a master in information studies or other discipline. The department expects to start with approximately five enrollments in the first year and hopes to increase their registration numbers to around thirty students in the long term.

Professor Bouthillier also explained that the certificate may serve as a stepping stone for the Master of Information Studies (MISt) as students may be interested in switching to the MISt program while doing the certificate since the completed courses can be counted towards MISt. However, once students have completed a certificate and then decide to do the MISt the understanding is that the courses completed in the certificate cannot be counted in the MISt.

Dean Kreiswirth and members of Council briefly discussed the extent of consultation required when developing new certificates and programs. The members of Council agreed that consulting related faculties as much as possible will help avoid duplication.

b) MSc in Neuroscience

Dr. David Ragsdale was invited to present the M.Sc. Thesis program in Neuroscience. He explained that the course NEUR 610 has been moved from the list of required 3-credit complementary courses to the list of complementary courses from which the student must obtain six credits. In addition, the credit weight from NEUR 610 has been changed from 5 credits to 3 credits. In consequence, the course NEUR 610 is no longer necessary for students to obtain credits since the credit weight for NEUR 610 now offers 3 credits. As a result, the proposed program will require a student to complete 45 credits to graduate.

Due to a lack of quorum, no motion was passed at the meeting. The vote will be taken electronically.

c) PhD in Neuroscience

Dr. Ragsdale also presented the PhD Thesis in Neuroscience. The major revisions included removing the course NEUR 610 from the list of required 3-credit complementary courses to the list of complementary courses from which the student must obtain six credits. The credit weight for the course NEUR 610 has also changed from 5 credits to 3 credits.
