BIOGRAPHIES OF PARTICIPANTS BIOGRAPHIES DES PARTICIPANTS

SARAH BERGER RICHARDSON is a doctoral candidate in the Faculty of Law at McGill University, where she holds a Joseph Armand Bombardier CGS Award. Her research focuses on the relationship between science and ethics in food law and policy, particularly in relation to food safety regulations and meat production. Sarah is a member of the Law Society of Upper Canada. She completed her LL.M at Tel Aviv University, where she was a research fellow at the Manna Center in Food Safety and Security. Previously, she was a law clerk at the Supreme Court of Israel and the Canada Agricultural Review Tribunal.

STEFANIE CARSLEY is a doctoral candidate at McGill University's Faculty of Law. Her dissertation examines Canadian legal responses to surrogate motherhood and explores the experiences, practices and perspectives of Canadian lawyers who advise and represent surrogate mothers and intended parents. She has published work on surrogacy in the *University of British Columbia Law Review*, and on assisted reproductive technologies more broadly in the *Canadian Journal of Family Law*, the *Health Law Review* and *Dalhousie Law Journal*. Her doctoral research is supported by the Joseph-Armand Bombardier Canada Graduate Scholarship and the Queen's Fellowship from the Social Sciences and Humanities Research Council (SSHRC).

JEAN-PHILIPPE CHÈNEVERT (Me) est titulaire d'un LL.B et d'une maîtrise en administration des services de santé de l'Université de Montréal. Avocat ayant pratiqué le droit de la santé pendant plusieurs années, il effectue en 2016 un retour à la faculté de droit comme doctorant. Ses recherches portent notamment sur la gouvernance, les politiques publiques et l'imputabilité des acteurs du système de services de santé et de services sociaux.

JOSÉANE CHRÉTIEN is a doctoral candidate interested in health law and ethical issues. She holds a master degree in comparative and European Law from the University of Oxford and a master degree from the University de Montréal. She is a member of the Québec Bar since 2003 and worked as a litigator for more than 10 years. She is a Research Fellow of the McGill Research Group on Health and Law.

GEOFFREY CONRAD is a doctoral student at McGill University's Faculty of Law, where he also obtained his bachelor's degrees in civil and common law. His principal research interests are in judicial decision-making and constitutional theory. His doctoral thesis explores the challenges that pluralism poses to constitutional adjudication involving the principle of proportionality, notably in the case of section 7 of the Canadian Charter of Rights and Freedoms.

MARIE-ANDRÉE GIRARD (Dre) a choisi, après avoir obtenu son doctorat en médecine de l'Université de Sherbrooke en 2004, de faire sa résidence en anesthésiologie et de poursuivre aussi son intérêt pour l'éthique et le droit en obtenant une maîtrise en droit de la santé à l'Université de Sherbrooke pendant sa résidence. ADAM R. HOUSTON works at the intersection of health, human rights and globalization. He has collaborated with organizations like Treatment Action Campaign, the Pacific Islands AIDS Foundation, Avocats sans frontières Canada, and the Institute for Justice & Democracy in Haiti. His research focus is legal interventions addressing infectious and noncommunicable lifestyle diseases in a global context.

ANNIE-PIERRE OUIMET-COMTOIS (Me) est avocate depuis 2007, titulaire d'une maîtrise en droit et politiques de la santé de l'Université de Sherbrooke et doctorante à l'Université de Montréal. Elle a pratiqué comme avocate dans le domaine du droit de la santé et de la psychiatrie légale pendant près de neuf (9) années et est membre du Comité scientifique et d'éthique à la recherche du CISSS de Laval. Ses recherches portent sur l'interrelation des domaines du droit et de la santé en matière de psychiatrie légale. Elle s'intéresse à l'application des procédures légales, telles les demandes de gardes en établissement, par les professionnels de la santé et les juges, ainsi qu'à leurs impacts sur les patients.

STEPHEN RICHARDS graduated from Swansea University with a First Class LLB in 2013. Whilst at Swansea he founded and served as President of Human Rights Action as well as volunteering for Asylum Justice. He moved to Ottawa in January 2017 and is currently doing his LLM under the supervision of Professor Jennifer Chandler. Prior to his legal studies Stephen worked in Estate Management and Investment Banking.

SUSAN ROGERS VAN KATWYK is an epidemiologist and PhD candidate in the University of Ottawa's School of Epidemiology, Public Health and Preventive Medicine. She is also a Research Associate with the Global Strategy Lab at the uOttawa Centre for Health Law, Policy and Ethics. Her dissertation research focuses on the effectiveness of policy and regulatory interventions to fight antibiotic resistance. Susan has a first-class honours degree in Biochemistry and Women & Gender studies from Mount Allison University. In addition to working with the Global Strategy Lab, Susan is a contributor to the UsefulScience website and was formerly an editor of the University of Ottawa Journal of Medicine.

ROBIN WHITEHEAD is currently a PhD Candidate at the University of Ottawa, Faculty of Law. She holds a J.D. from the University of Toronto and is a member of the Law Society of British Columbia. Her research examines the interface of policing and the mental health system, with a particular focus on the impacts of police policies and practices on the human rights of persons with mental health disabilities

MA'N H. ZAWATI (Me) is a lawyer and the Executive Director of the Centre of Genomics and Policy at McGill University. He is also an Associate Member of McGill's Biomedical Ethics Unit since 2013.
