**FLORENCE ASHLEY** is a transfeminine jurist and bioethicist, and current LL.M. Candidate at McGill University with a specialisation in bioethics. Their work spans a wide array of issues in law and healthcare as they relate to trans realities.

**STEFANIE CARSLEY** is a doctoral candidate at McGill University's Faculty of Law and an incoming Assistant Professor at the University of Ottawa's Faculty of Law, Common Law Section (July 2019). Stefanie's research focuses on Canadian law and policy responses to assisted reproduction (*in vitro* fertilization, surrogate motherhood and sperm, egg and embryo donation). Her doctoral research was supported by the Joseph-Armand Bombardier Canada Graduate Scholarship and the Queen's Fellowship from the Social Sciences and Humanities Research Council.

**GERARDO CENTENO GARCIA** is a law student coming from Mérida, México. He attained his Bachelor of Laws' degree at the Anahuac Mayab University, and, recently, got his Master of Laws' degree at the University of Ottawa. He previously worked at the Senate of the Republic of Mexico and in Ernst&Young Mexico. His interests are within tax, transparency, health and constitutional law.

JOSÉANE CHRÉTIEN is a doctoral candidate interested in health law and ethical issues. She holds a master's degree in comparative and European Law from the University of Oxford and a master's degree from the Université de Montréal. She has been a member of the Québec Bar since 2003 and worked as a litigator for more than 10 years. She is a Research Fellow of the McGill Research Group on Health and Law.

**MARY HEINEN** is completing her Master's of Science in the Department of Family Medicine and the Biomedical Ethics Unit. Her interests are primarily health policy ethics and ethical issues that arise in health law and policy. Her graduate research involved applying a patient-centered care ethical framework to Health Canada's proposed policy to regulate reimbursing gamete donors.

**KARINE MILLAIRE** is a doctoral candidate at the University of Ottawa pursuing research related to the adjudication of constitutional rights by courts, legal theory and philosophy. She is a lawyer since 2008 and holds a master's degree from Université Laval in human rights. She previously worked as a litigator in public law for Justice Quebec for five years.
