#### **Milestones**

In September 2015, a Group of Experts met at McGill University, Montreal, Canada, to discuss embarking on a project to draft the Manual on International Applicable to Military Uses of Outer Space (MILAMOS). The meeting was attended by numerous interested parties from across the world, including experts in international humanitarian law, military space operations, governmental space policy and space law from different States.

The attendance of subject-matter experts, policy-makers and representatives from the International Committee of the Red Cross underlined the significant international interest in and originality of this project. The Group of Experts agreed that a collective of international scholars and experts acting in their individual capacity is necessary to ensure the widespread participation, neutrality and legal objectivity of such a manual, and that steps must be put in place to move the project forward. The event was made possible with the support of the Government of Canada and the Erin J.C. Arsenault Fund at McGill University.
