#### Introduction:

The Centre for Research in Air and Space Law (CRASL) is the research wing of the Institute of Air and Space Law, which was established in 1951 and based at the Faculty of Law of McGill University. The CRASL was established in 1 September 1976 (with the official consent of the *Ministère de l'éducation du Québec*). The Centre's research and outreach activities are international, interdisciplinary, and ambitious in nature. The Centre is headed by the Director, day-to-day management is conducted by the Centre's Executive Director, and its activities are overseen by a Board of Directors. Currently, Prof Lara Khoury chairs the Board of Directors.

At the last Annual CRASL Board Meeting, held on Friday, 24 March 2017, the Board accepted the proposals by the Director to formalise and strengthen the organisational structure on the basis of its By-Laws that were adopted in 2015. For this purpose, the Board confirmed the appointment of Prof Dr. Paul S Dempsey as an Associate Member, Dr. Md Tanveer Ahmad as the Executive Director, and Mr. Kuan-Wei (David) Chen as the Director of Publications. In addition, the Board also authorised the Director to appoint more full members and associate members. On his invitation, several of experts have accepted to join the CRASL as Associate Members. #### Milestones

In May 2017, the CRASL concluded an agreement with HeinOnline, a legal publisher, periodical subscription agent, and the world's largest distributor of legal periodicals from the United States, for the publication and distribution of all CRASL publications, including the *Annals of Air and Space Law*. The idea of getting all CRASL publications online has been under consideration for the better part of the past decade. All CRASL publications will become available online in the HeinOnline Digital Library, except the publications from the last two/three years, which can be purchased. In addition, HeinOnline will market/promote and distribute physical copies of our existing books, as well as produce/print, market, and distribute our future publications. It is believed that the Agreement will help us in saving time and money, expanding our market and visibility, attracting more high quality papers, and generating more revenue.

The Inaugural Plenary of the McGill Manual on International Law Applicable to Military Uses of Outer Space (MILAMOS) Project was held in Montreal on 3-5 October 2016. This three-year Project has been initiated by the CRASL, and is being carried out in collaboration with the University of Adelaide, Australia and the University of Exeter, UK. Over 40 legal and technical experts from various counties are participating in the Project, which has its Secretariat at the CRASL. This CAD\$ 1.5 million project, aimed at producing the McGill Manual, will be a highly innovative one and will be carried out through international workshops being organised in various parts of the world. The first such workshop was held in Adelaide, Australia, on 20-23 February 2017 and the second one held in New Delhi, India, on 20-23 June 2017.
