Les *Annales de droit aérien et spatial* sont publiées par le Centre et l'Institut de droit aérien et spatial, McGill University, Montréal, Canada. Depuis 1976, les Annales rassemblent, sous une même couverture, des articles originaux, en anglais et en français, d'éminents universitaires, praticiens, étudiants de l'Institut et autres spécialistes en droit aérien et spatial. Elles traitent non seulement des problèmes d'intérêt juridique actuel mais aussi de ceux qui se développent à lumière des nouvelles activités aéronautique et spatiales. Ces dernières sont aussi analysées dans leurs multiples implications techniques, socio-économiques ou politiques au sein des organisations internationales.
