



## INTD397: Nationalism, Ethnicity, and Conflict (INTD397-Section 2) Fall 2020

### **I. COURSE DESCRIPTION:**

Ethnic conflict is one of the most powerful forces shaping contemporary politics and remains a prevailing challenge to international security of our time. Unresolved or poorly managed ethnic conflicts can pose serious threats to human lives, domestic stability and territorial integrity of existing states. They can spill over from one country to another and destabilize an entire region. The wide variety of ethnic conflicts that exist today also raise serious questions about the role of international actors.

In this course, we will discuss the meaning of ethnicity, its relation to nationalism, and the theories that indicate why ethnicity and identity can lead to conflict. The goal is to use an interdisciplinary approach and build a framework for understanding and analyzing ethnic conflict at both the theoretical and practical level. We will also consider approaches to group conflict management and resolution, evaluating the probabilities of establishing and maintaining a stable society politically, economically, and socially.

By the end of the course, students should be able to:

- Explain the main theories of ethnic identity and their relevance to ethnic conflict.
- Identify the conditions under which such conflicts are likely to exist and persist
- Evaluate and discuss the existing policy solutions to mitigate and/or prevent ethnic conflict
- Explain the causes and consequences of conflict in several cases discussed throughout the course: Canada, Rwanda, the Balkans, Sri Lanka, and the Kurds in the Middle East.

**II. REQUIRED READINGS:**

All of the required texts are available and be posted on *MyCourses*.

**III. COURSE ASSESSMENT:**

**1. Brief Reflections: 5\*2%=10%**

Each student will write 5 out of 6 Brief Reflections (200-250 words each) on various topics related to the course. The prompts for these Reflections will be posted on *MyCourses* >> *INTD397* >> *Content* >> *Brief Reflections* ahead of time (see the table below). These Reflections will be for you to explore topics discussed in class and readings; I shall **NOT** grade these strictly on content, but rather on your effort in reflecting on the particular topic. Student must upload their Reflections to the designated folders on *MyCourses* >> *INTD397* >> *Assignments*. Email submission will **NOT** be accepted.

Students will have one free pass to miss a Reflection without being penalized. Therefore, **NO FURTHER ACCOMODATION** will be provided to students who miss more than one reflection. Students are advised to use their free passes wisely. Brief Reflections will start after the add/drop period. Please see the following table for submission deadlines.

**BONUS:** If a student submits all 6 reflections, the lowest grade will be dropped.

## 2. Midterm Exam: 25%

Students will have to write one take-home exam worth 25% of the total grade. I will post the questions on *MyCourses* >> *INTD397* >> *Midterm Exam* on **Tuesday Oct 13, at noon (EST)** and students must upload their answers (in PDF format; file name: *last name, first name*) by **Friday, Oct 16 at 11:59pm (EST)**. The exam will be in short essay format and will cover the concepts and topics covered in the course readings and lectures up to and including Week 6.

THERE IS ABSOLUTELY NO EXTENSION ON THIS ASSIGNMENT. LATE SUBMISSION =0

Students must submit their assignments to the designated folder on *MyCourses*>> *INTD397* >> *Assignment*.

## 3. Critical Essays:

Students must choose ONE of the following cases for this portion of the course evaluation.:

- Cyprus
- Chechnya
- Northern Ireland
- Sudan (Darfur)
- Spain (Catalonia)
- Kashmir

### A. First Critical Essay: 30%, due on Friday, Nov 6 (11:59pm (EST))

Students should select a case of ethnic conflict from the list above; and:

- 1) summarize the major elements of the conflict and address:
- 2) make an argument about the principal reasons for the conflict by answering to the following questions:

- a) What causes lead to conflict in the chosen case?
- b) Why is this cause more or less important than other possible causes?, and
- c) How does this cause interact with other possible causes of conflict? Students may argue for more than one cause of the conflict, but must prioritize the arguments well.

This is a maximum 5-page paper excluding bibliography (Times New Roman font, double-spaced, 12-font size, 2.5 cm margins on all sides). More information and instructions will be available on *MyCourses* >>INTD397 >> *content* >> *Critical Essay Guidelines*. Student are expected to submit their essays in PDF copies to *MyCourses*>>INTD397 >> *Assignment* by **Friday Nov 6 (11:59pm (EST))**. Email submission will **NOT** be accepted.

**B. Second Critical Essay: 35%, due on Friday Dec 4 (11:59pm (EST))**

Adhering to the case used for the first critical assignment, students should now focus on answering the following questions:

- 1) What mechanism or processes reduced (could reduce) civil conflict in the chosen case and why?
- 2) Why didn't this mechanism/process stop or reduce civil conflict prior to the cessation of hostilities?
- 3) Why is this mechanism/process more or less important than others for successful conflict resolution?
- 4) If the conflict chosen is still underway, students may propose a mechanism that they believe would be most successful in resolving the conflict in the future.

This is a maximum 6-page paper excluding bibliography (Times New Roman font, double-spaced, 12-font size, 2.5 cm margins on all sides). More information and instructions will be available on *MyCourses*. Student are expected to submit PDF copies on *MyCourses* >> INTD397 >> *Assignments* by **Friday Dec 4 (11:59pm (EST))**. Email submission will **NOT** be accepted.

Please follow the guidelines on writing a research paper provided on *MyCourses*, such as formatting and citation rules, as well as the thesis and content. Provide clear arguments and support through literature for your arguments. Should you have questions, do not hesitate to approach me, or attend the writing workshops (*see below*).

It is students' responsibility to check their Internet connection and other technical issues before submission.

**Important Note:**

- Late assignments will be marked down one letter grade one letter grade per day late as of then (for example: A → A-).

There will be one live introductory lecture held via Zoom on **Wednesday, September 2 at 4:30pm (EST)**. This is the only live lecture we will have in this course. The lecture will consist of two parts: an introduction to the course and course requirements followed by a Q&A session. The first part of the lecture will be recorded and posted on *MyCourses* for students who are unable to join the live lecture. The Zoom link and passcode to the lecture will be posted in the announcement section of *MyCourses* >>INTD397.

The lectures in this course will be pre-recorded and posted on *MyCourses* >> INTD397 >> *Lecture Recordings* every Wednesday. The recordings are **NOT** downloadable. Please note that we will **NOT** have live lectures on Zoom throughout the semester (except for the one introductory lecture mentioned above). Moreover, lecture slides will be available for download on *MyCourses* >> INTD397 >> *Content* >> *Lecture Slides*.
