### ABOUT MCGILL UNIVERSITY FACULTY OF LAW

### Exchange Application Deadlines 2024-2025

#### Fall 2024 and Full-year exchange deadlines:

- Nomination deadline: April 12, 2024
- Student application deadline: April 12, 2024
- Student supporting document deadline: May 1, 2024

#### Winter 2025 exchange deadlines:

- Nomination deadline: August 15, 2024
- Student application deadline: August 15, 2024
- Student supporting document deadline: September 1, 2024

We cannot guarantee applications will be accepted beyond these dates. If you encounter difficulties in submitting the applications within the deadlines, please contact [exchanges.law@mcgill.ca](mailto:exchanges.law@mcgill.ca) prior to April 12, 2024, for Fall 2024 and Full-year exchanges, and prior to August 15, 2024, for Winter 2025 exchanges.



**\*Note about Winter 2025 exchange deadlines:** registration for **both** Fall 2024 and Winter 2025 courses open **mid-July 2024** for all newly admitted Fall 2024, Full-year and Winter 2025 exchange students. We recommend that Winter 2025 applications are submitted before that date so that Winter term exchange students can register for their courses along with other newly admitted exchange students in June.

**Minimum Academic Requirements**

- Must be in good standing and have completed at least one full academic year in a University (law program) by the time you go abroad
- Cumulative **CGPA of 3.00 out of 4.00 (B average)** is required for consideration

**Fall 2024 Semester**

- Fall semester classes: August 28 to December 4, 2024
- Fall break: October 15 to 18, 2024 (inclusive)
- Fall semester examinations: December 6 to December 20, 2024

**Winter 2025 Semester**

- Winter semester classes: January 6 to April 11, 2025
- Winter reading week (no classes): March 3 to March 7, 2025 (inclusive)
- Winter semester examinations: April 14 to April 30, 2025

## Bilingual Language Policy

McGill's Law program is offered in a bilingual, English & French, environment. While most courses at McGill are offered in English, and the ability to communicate in English is a requirement, irrespective of the language of instruction at the Faculty of Law, reading of complex substantive texts in French and English are assigned in many upper-year law courses. In certain courses, such as private law courses, students will be assigned readings in French.

While examination questions are set in the language in which a course is given, any examination may contain extensive passages in either French or English. To fully participate in courses, communicate fully with all law students and be fully immersed in Montréal's culture, the ability to speak and read French is an asset. Students should consider this when selecting courses and are welcome to contact Faculty advisors with any questions or concerns.

## Orientation

**Faculty of Law:** The Law Faculty organizes orientation information sessions for all newly admitted exchange students. The session for Fall term and full-year exchange students takes place in late August/early September. The session for newly admitted Winter term exchange students will take place in January.

**International Student Services Office:** McGill's International Student Services Office hosts webinar information sessions on their website prior to arrival at McGill so that students can learn more about McGill, Montreal, Study Permits, Health Insurance, Housing, Banking, Cell phone plans, Orientation, and more. ## Course Registration

Law course information is updated each year in May on the [Faculty of Law's website](#), including course offerings and examination timetables. Please note that courses may be added or cancelled, and changes may be made throughout the academic year. We cannot guarantee that the same courses will be offered in the same terms in future academic years.

Exchange students may start registering for courses on Minerva, for both terms, in **mid-July 2024** provided their application and nomination have been received and accepted. Students must take at least 12 credits per term to be considered a full-time student. Incoming Exchange students can register for most of our undergraduate law courses, and undergraduate sections of graduate-level courses upon availability and any necessary approvals. Incoming Exchange students **may not register** for first year (1L) and second year (2L) required courses, Moots, Clerkships, Legal Clinics, Group Assistant and Term Essays.

Please note that McGill Law students have priority registration early courses may be full as priority is usually given to our Law students upon early registration, and we cannot guarantee spots will be available within specific courses.
