3. Obligations

particularly with regard to discipline, health and safety.

- iv. During his stay abroad, he shall obey all the federal and provincial laws and regulations and those of the host country; he shall also adhere to all the codes, policies, rules and procedures of the University.
- v. As applicable, he shall be responsible for ensuring that his visa(s) and/or any other travel documents required are valid, accurate, current and in compliance with the laws and regulations of the host country for the duration of the activity.
- vi. It is his responsibility to cover all expenses, make all travel plans and arrange all accommodations related to the activity.
- vii. He shall be fully qualified and hold all the authorizations needed to perform all of his tasks.

b) Host organization:

- The host organization shall provide the student with appropriate tasks, counseling and guidance as well as an environment that is conducive to the student's learning and professional development.
- ii. At the end of the activity, it shall issue a report, evaluation or notice concerning the student's work.
- iii. Following agreement with the student, it shall supply the latter with certain equipment and material deemed necessary for the purposes of the activity.

4. Student's status

5. Remuneration or bonus

The student shall receive a remuneration, bonus or other form of compensation based on the declaration that he signed with the host organization, as indicated below:

The student and the host organization, in compliance with the declaration binding them, shall assume full responsibility for any deductions to be made from the remuneration, bonus or other form of compensation and paid to any government authority. In other words, the University will not be held responsible for any deductions, fees or levies payable to any government body or other authority in respect of the relationship between the student and the host organization or pursuant to this declaration. Under no circumstances will the student be considered an employee of the University.

6. Privacy

The student agrees, during the course of the activity and at all times after the expiry of this declaration, to protect any and all information relating to the host organization that is intended to remain confidential. This includes, without being limited to, any and all confidential information obtained, any and all reports, documents and work completed, and any and all documentation acquired, created and/or produced during the activity.

7. Intellectual property

As regards intellectual property, the student shall be bound by the regulations and policies applicable to the University, including, without being limited to, the *Policy on Copyright* and the *Policy on Inventions and Software*. If the said policy does not apply to the present case, the intellectual property shall be governed by the agreement concluded between the student and the host organization; in the absence of such an agreement, it shall be subject to the laws in effect.

8. Insurance

- a) It is the student's responsibility to obtain, before his departure for the location of the activity, the necessary medical, travel, accident and individual insurance coverage.
- b) Upon request, the student shall present evidence of such insurance coverage to the University.
- c) Notwithstanding the provisions of section 8 a) of this declaration, the host organization and the student hereby confirm that, further to their agreement, the student shall obtain all the necessary insurance coverage to demonstrate caution and diligence in carrying out the activities described in this declaration. In other words, McGill accepts no responsibility for obtaining any insurance coverage whatsoever for the activity described in this declaration.

9. Termination

a) The University, the host organization and the student may, without incurring liability, terminate this declaration before the end of the activity, for any reason or

motive. A termination notice must be provided at least (2) weeks before the effective date of such termination. It must comply with the provisions set forth in section 11 of this declaration.

b) If the student violates a policy, regulation or procedure of the host organization or adopts a behavior deemed unacceptable by the host organization, the latter may immediately terminate this declaration without notice.

10. Amendments to this agreement

The University, the host organization and the student may agree to amend the provisions of this declaration. If so, any amendment shall be confirmed in writing, in a document signed by the authorized representatives and delivered in compliance with the procedure set forth in section 11 relating to advance notices.

11. Notice

Any notice required or authorized (the "notice") pursuant to this declaration shall be provided in writing. It shall effectively be provided insofar as it is hand-delivered or sent by messenger service, registered mail or email to all parties concerned:

the student, including, without being limited to, the interruption or non-delivery of services, whether or not such damage results from the negligence of the property's owner or that of one of its agents, officers or employees or any other person for whom the said owner may be legally liable.

b) The host organization and the student undertake to indemnify the University for any fees, legal proceedings or claims arising from the activity.

14. Jurisdiction and applicable law

Any dispute arising from this declaration and/or the activity shall be under the exclusive jurisdiction of the courts of the province of Quebec, located in Montreal, Canada.
