



BRITISH NORTH AMERICA, 1760-1867: PRIMARY SOURCES

This guide lists items found mainly in the GOVERNMENT INFORMATION SERVICE (McLennan-Redpath), unless otherwise indicated. Many more titles are available in McGill Libraries. Please check MUSE, McGill's online catalogue for others. You can search MUSE by author, title, subject, and keyword. Many titles are also listed in the card catalogue in the Government Information Service. Please ask library staff at the Government Information Reference Desk for assistance.

The documents indicated below fall primarily into the following main categories:

DEBATES: Sometimes referred to as Hansard, Debates provide a verbatim account of what is said in Parliament or a provincial legislative body. When the quality of the rhetoric is high, Debates can supply pungent quotes for a research paper.

JOURNALS: The Journals summarize the proceedings of a legislative body in chronological order. They are useful when searching for a quick overview of the events that transpired in the legislature. One can readily find out, for example, if a bill passed or not, without having to sift through all the verbiage found in the Debates.

SESSIONAL PAPERS: These are also known as either Parliamentary Papers, Supplements or Appendices to the Journals. In this set are bound together reports tabled in a legislative body. These can include Annual Reports of departments, reports of committees, statistical information such as the returns of the Census, reports of business institutions, royal commissions, etc. Sessional papers are an inestimable source of economic, political and social documentation.

STATUTES: These are the written laws approved by legislatures, parliaments or houses of assembly. They may also be referred to as legislation or acts.
