2. Course Description

This course is an examination of the structure of a specific language. We will investigate aspects of the phonology and syntax of Portuguese within the theoretical framework of generative linguistics. The objective of the course is twofold: (i) to apply and refine analytical methods in linguistics based on phenomena from Portuguese, and (ii) to identify empirical generalizations that contribute to the understanding of generative theory.

3. Prerequisites

LING 330 (Phonetics), LING 331 (Phonology 1), and LING 371 (Syntax 1); or permission of instructor. Knowledge of Portuguese is not necessary.

4. Format

This course comprises lectures, discussion of data, team work and reading. Student participation is highly encouraged. Course materials (including readings) will be available on MyCourses. Slides will normally be posted on MyCourses after class.

5.1 Quizzes

The quizzes will be composed of multiple choice, true/false and short answer questions, in addition to a few questions that require a short analysis. The quizzes will be done in class, and they should take no longer than 30 minutes. The quizzes should be written in pen (otherwise they cannot be considered for re-grading).

5.2 Assignments

Assignments can be done in groups (maximum 3 students), but each student must turn in his/her own assignments and **write them up individually**. Students **must** include in their assignments the name of the student(s) with whom they worked.

Assignments are due at 5:00 p.m. on the due date. Students must submit their assignments through MyCourses. Notify the instructor in advance if for some reason you will not be able to use MyCourses to turn in your assignment.

5.3 Final project

In groups of 2 or 3, students will select an issue of interest in Portuguese linguistics and propose an analysis that accounts for it. Your analysis will consist of a critical review of one or more articles that discuss the topic of your choice. You are allowed to include your own data in the analysis (i.e., you can consult native speakers or obtain data from an online database). You are also allowed to compare the Portuguese data with data from a different language, and to provide an analysis that accounts for the differences/similarities between the two languages. The analysis must be written up as a short paper (2-3 pages plus figures/trees/tableaus) and presented in class during the final week of classes. Students are encouraged to meet with the instructor before writing up their papers. Further instructions will be posted on MyCourses by the end of September.

5.4 Late assignments and missed quizzes

Late assignments will not be accepted unless the student has a certified medical excuse. No make-up quizzes will be given to anyone who does not have a certified medical excuse.
