



## *Faculty Lecturer – Dietetics Educator (RD-MSc)*

#### Position description

The School of Human Nutrition of the Faculty of Agricultural and Environmental Sciences is seeking applications for a full-time position (2-year term) at the rank of Faculty Lecturer. The successful candidate will serve as a Dietetics Educator and will teach required undergraduate and/or graduate courses in the School. The candidate will be joining an established team of Dietetics Educators (Professional Practice (Stage)).

#### Job duties

Primary responsibilities will include the development of distant dietetics Stage placements within the province of Quebec, liaison with Stage placement preceptors, teaching responsibilities, and the coordination/supervision of student Stage placements. The successful candidate will contribute to services within the School such as participating in curriculum revision, simulation activities and student advising.

#### Qualifications and education requirements

The successful candidate will have a MSc in nutrition or related area and be a registered dietitian (R.D. or P.Dt.) with membership, or eligibility for membership, in l'Ordre des diététistes nutritionnistes du Québec (ODNQ). Experience in clinical and/or community dietetics practice, in teaching and student supervision, as well as excellent French and English skills are required. Preference will be given for candidates with relevant clinical experience in a multidisciplinary environment in the public sector of health care in Quebec. Candidates must be committed to and demonstrate excellence in both the teaching and learning of students, contribute to a student-centered environment that nurtures and challenges students, and show commitment to equity and diversity in their teaching practice.

The Faculty of Agricultural and Environmental Sciences ([www.mcgill.ca/macdonald](http://www.mcgill.ca/macdonald)) is located on McGill University's Macdonald Campus, which occupies 650 hectares in a beautiful waterfront setting on the western tip of the island of Montreal.

The School of Human Nutrition ([www.mcgill.ca/nutrition](http://www.mcgill.ca/nutrition)) offers 3 dietetics programs: the 115-credit BSc (NutrSc) Dietetics Major (40 weeks of Stage), the 83-credit MSc Applied in Human Nutrition, Dietetics Credentialing option (34 weeks of Stage plus a 6-credit project), and the 30-credit (34 weeks of Stage)

Graduate Diploma in Dietetics Credentialling (offered ad hoc to students with a PhD in Human Nutrition and all the coursework completed).

The Dietetics Major is recognized by l'Ordre des diététistes nutritionnistes du Québec to meet the academic and internship requirements to be a registered dietitian/nutritionist in Quebec. Stage placements are integrated with academic courses throughout the program.

The School of Human Nutrition is also a research-intensive unit with ongoing activities in our on-site research facilities, including the newly renovated Clinical Nutrition Research Unit, as well as the Centre for Indigenous Peoples' Nutrition and Environment, and the Margaret A. Gilliam Institute for Global Food Security. Other McGill-affiliated research and health centres ([www.mcgill.ca/research/about/partners](http://www.mcgill.ca/research/about/partners)) include McGill University Health Centre teaching hospitals and McGill University Genome Quebec Innovation Centre.
