## TERMS AND CONDITIONS FOR USE OF COLLECTION MATERIAL

## **General Considerations**

The Maude Abbott Medical Museum is part of the Faculty of Medicine, McGill University. Its mission includes the collection, preservation, research and display of artifacts pertaining to the history of medicine. These artifacts are the property of the University, which has assigned custodial and curatorial responsibilities for them to the Museum. Use of any material in the Museum's collections whether for academic (e.g., teaching, research, publication, etc.) or other (e.g., promotional, commercial, etc.) purposes requires permission from the Advisory Board of the Museum. Terms of Reference for the Advisory Board, including membership, are available on the Maude Abbott Museum website found here (https://www.mcgill.ca/medicalmuseum/links).

## **Specific Conditions**

- 1. Express written permission is required from the Museum prior to the publication of any image or use of any object, reproduction or other material in the Museum's collections. (See separate application form (available on the website URL).
- 2. The Museum reserves the right to invalidate (terminate) any permission granted if the uses made by the User exceed or do not comply with the uses described in the requesting document.
- 3. For publication, permission implies a <u>non-exclusive license</u> to reproduce images of the requested materials for a specific use and term to be described by the User. In granting permission for such use, the Museum does not surrender its right to use any of the images/materials from its collections or to grant others permission to use any such images/materials.
- 4. Permission is granted for <u>one-time use only</u>. By providing the User with images or material for a specific purpose(s), the Museum does not grant permission for the User to employ them/it for any other purpose. <u>Additional written permission</u> (and possibly fees) are required for each additional use of the image(s)/material.



- 5. Images or reproductions may not be used to show or imply endorsement by the Museum of any commercial product or enterprise.
- 6. Images or reproductions requested by the User will, as a general rule, be provided by the Museum. In some circumstances, and following specific agreement by the Museum, the User may be permitted to take his/her own images/reproductions of a specific object.
- 7. Any alteration to an image or reproduction provided by the Museum such as color manipulation, cropping or addition of an overlay text is prohibited without written permission. Such unauthorized alteration of images will render any prior agreement to use an image(s) or reproduction(s) void.
- 8. Due to the sensitive nature of some of the Museum's collections, some photographic/reproduction and usage restrictions may apply.
- 9. The User agrees to take due care to protect all images/reproduction(s) from unauthorized use by any person or entity.
- 10. Credit to the Museum (adjacent to the place in which an image, reproduction or object is used and/or in an appropriate acknowledgement section) must be given for each item used. The wording and nature of such credit shall be agreed to by the Museum in advance of publication/use of the material.
- 11. Depending on the requestor and the nature of the request, research and production fees may apply.
- 12. Verification is required from a User who asserts non-profit status.
- 13. For material that is loaned and transported to a site outside the Museum, details of the mechanism of transfer shall be decided in concert with the Museum. An appropriate insurance policy to offset damage may be required. The particular conditions applying to the loan and transport of an artifact outside of the Museum may be included in a separate document agreed to between the parties.
- 14. The Museum does not claim copyright of all pictorial materials in its collections, or provide any warranty or representations regarding any underlying intellectual property or other ownership rights in and to the object(s) and/or materials to be reproduced, including any rights under copyright, trademark, right of publicity, or any other rights. The right to reproduce images of any such object(s) and/or materials is granted "AS IS", and User is solely responsible for determining whether or not any third parties own, or have any claims to, or any rights in and to the object(s), image(s) and/or materials to be reproduced, and for obtaining any such rights as may be required. Where an object and/or image is subject to copyright, no warranties or representations are made by the Museum as to any third party rights in the copyright thereof, and the User shall be solely responsible for obtaining permission from the copyright owner of the object and/or image, if



any, and shall be required to indemnify the Museum against any claims or damages resulting therefrom. The User shall provide copies of any such third party licenses upon request of the Museum.

- 15. The User hereby indemnifies and holds harmless the Museum, its directors, officers, employees, agents, and assigns, from and against any claims or damages whatsoever, including reasonable attorney's fees, with respect to any third party claims arising from the User's use of Museum objects, images and/or materials, including any claims arising from the User's failure to investigate and license any third party rights in such objects, images and/or materials.
- 16. The information set forth in the Agreement, including these Terms and Conditions, represents the entire agreement between the parties and supersedes any prior agreements or representations, oral or written. The Agreement may not be modified except in a writing signed by both parties. Waiver of any right under the Agreement at any time does not constitute a later waiver of any rights. The parties shall at all times be considered independent contractors and nothing in the Agreement creates any partnership or joint venture. The Agreement, including its rights and obligations, may not be assigned by the User without the Museum's agreement in writing. The Agreement shall be construed under the laws of the Province of Quebec and Federal laws applicable therein, and any disputes shall come under the venue and jurisdiction of the Court of the Province of Quebec, District of Montreal.
