Position description

The Department of Psychiatry at McGill University is currently inviting applications for two full-time positions as members of the Contract Academic Staff at the rank of Assistant Professor (Clinical). These will be three-year, renewable appointments.

The successful candidates will have a broad range of clinical abilities in adult outpatient psychiatry and an academic track record, demonstrated by experience in education and/or an active research dossier. The candidates will be appointed to clinical practice at the Jewish General Hospital.

The Jewish General Hospital's Department of Psychiatry, Institute of Community and Family Psychiatry, offers a full range of services for children, youth, adults and geriatric patients (inpatients and outpatients). There are active research programs in trans-cultural psychiatry, psychosocial health, psychotherapy and family therapy, sleep and aging, and first episode psychosis. The department's mission is to provide excellent clinical care in an academic environment. The department uses family systems and biopsychosocial models to understand patients and their families and utilizes a full range of evidence-based treatments. The department is proud to host a respectful, multi-disciplinary and inclusive work setting in its multiple areas of activity, which includes the training of a diverse group of students from medicine, psychology, occupational therapy, nursing, and social work.

The department is affiliated with McGill, Canada's most international university, which is located in vibrant, multicultural Montreal, in the francophone province of Quebec.

Job Duties

The successful candidates will be expected to provide excellent clinical teaching and supervision to residents and medical students, to participate in hospital administrative activities, to pursue scholarly activities, and are expected to make innovative contributions to the academic mission of the department, with strong commitment to equity, diversity and inclusion in these areas.

Requirements

- Applicants must have completed advanced Psychiatry training (fellowship/graduate studies).
- Applicants must hold or be eligible for licensure as a psychiatrist in the province of Quebec.
- Advanced capacity to engage in all aspects of a university affiliated psychiatry department (clinical, education, research).

- Clinician-scientists with MD-PhD or equivalent research-intensive training are encouraged.
