



JOHN MCCALL MACBAIN, O.C., BA'80, LLD'14 Honorary Chair

Dr. John McCall MacBain, originally from Niagara Falls, Ont., is the Founder and President of the McCall MacBain Foundation and Pamoja Capital SA, its investment arm. He was previously the Founder, President and CEO of Trader Classified Media, which was the world's leading classified advertising company

Dr. McCall MacBain earned an Honours BA in Economics from McGill, an MA in Law from Oxford, where he attended as a Rhodes Scholar, and an MBA from Harvard Business School. He currently devotes a significant amount of his time to philanthropic activities. He is the chair of the Principal's International Advisory Board at McGill, a Second Century Founder of the Rhodes Trust, and served as the chair of the 110th Rhodes Anniversary. In February 2019, he and his wife Dr. Marcy McCall MacBain donated \$200 million to establish the McCall MacBain Scholarship Program at McGill.

The McCall MacBains live in Geneva, Switzerland; he has five children, including a daughter who is a McGill Law graduate.

GARVIN BROWN, BA'91 Co-Chair

Garvin Brown is a graduate of McGill University (BA, Political Science and History), the University of British Columbia (MA, Political Science) and London Business School (MBA).
