

# 1. Deposits


Can a landlord ask for a security deposit upon signing the lease?





## 1. Deposits

• The landlord is **not** allowed to ask for a deposit. The landlord may, however, ask for the first month's rent in advance. Any clause to the contrary in the lease is invalid.



## 2. Repairs and Maintenance

• Who is responsible for repairs : the tenant or the landlord?

#### Landlord

- Urgent and necessary repairs
- Damage caused by the old age of the property
- Damage caused by superior force

#### Tenant

- Minor maintenance repairs
- Damage caused by the tenant or visitors



## 2. Repairs and Maintenance

# Whose responsibility is it?

- There is water damage in the apartment.
- The tenant hosted a party in his dwelling. A rowdy guest climbed on a table, lost their balance and fell on the floor. The impact formed a hole in the wall.



## 2. Repairs and Maintenance

# Other Landlord Responsibilities...

- Provide peaceable enjoyment of the property
- Maintain temperature at 21 degrees Celsius in the winter (Montreal)
- Provide a dwelling that is fit for habitation













## 3. Obligations owed to co-tenants

What happens if my co-tenant is late on paying rent?

Joint Liability

- Each tenant is responsible for their share of the rent.
- Each share is presumed equal.
- Default arrangement.

Solidary Liability

- Each tenant is responsible for the entire rent.
- Box H on the lease.



# 4. Resiliation of the Lease




## 4. Resiliation of the Lease

#### False!

A lease can be resiliated (by the tenant) in one of the following circumstances:

- The tenant is relocated to a low-income housing unit by a judge.
- The tenant is no longer able to live in the dwelling due to a disability.
- The tenant is victim of spousal violence or sexual abuse.
- A tenant is disturbed by another tenant or their visitors.
- The non-performance of an obligation by the landlord caused serious injury to the tenant.
- The landlord did not carry out urgent and necessary repairs to ensure the preservation or enjoyment of the leased property.

- New Contract
