## INTRODUCTION

There is no doubt that the Department is in a profound, perhaps unprecedented, period of change. Part of this change is extrinsically imposed by external influences and decisions that necessitate self-evaluation, reflection, and alterations in set ways and approaches. A new hospital with space limitations, forthcoming adjacencies to maternal, adult and rehabilitation service providers, profound modifications in the undergraduate medical curriculum, the implementation of new contractual work rules for resident staff, a government mandated shift to community care provision that redefines the roles of both pediatricians and pediatric sub-specialists, are all examples of such extrinsic changes. As if these extrinsic forces of change are not sufficiently challenging, a *'perfect storm'* of fiscal constraints is emerging; a university tuition freeze coupled with arbitrary government mandated funding cutbacks, RM changes in physician compensation formulas, cuts in *Agence* & MUHC budgets that are predicated on some 'magical' increased efficiency despite declining resources, research funding shortfalls, and an economy that is not yet fully conducive to philanthropic giving.

But change in our instance is also intrinsic. The Mission/Vision/Values statement adopted by the Department is an eloquent, explicit elucidation of this intrinsic change. A commitment to patient and family centered care, transparency, accountability, collegiality and collaboration are but a few of the values that impart personal responsibility not only to ourselves, but to others in our community. There

is a new leadership membership, style and model now firmly anchored into place. The Department is well positioned to advantageously exploit the multiple opportunities before it as a result of change.

## **MISSION, VISION & VALUES – MCGILL DEPARTMENT OF PEDIATRICS (adopted Fall 2012)**

**Mission:** Through excellence and leadership to optimize the health & wellbeing of infants, children, and youth within the context of their families.

**Vision:** Our mission will be accomplished through the following practices:

2. Dynamic education of professionals involved in pediatric health that puts the needs of learners first
3. Innovative and transformative research in pediatric health at the bench, at the bedside, in the clinics, and in the population at large

## RESEARCH & PUBLICATIONS

Our research efforts continue to garner significant external funding, particularly for external peer-reviewed salary awards. Members of our Department received 6 out of the 8 total awarded to the McGill University Health Centre Research Institute for 2012. The salary awards for Pediatrics total slightly over \$1.1 million for the 18 investigators. The total of external peer-reviewed grants and awards received by the RI, with the majority being specific to the Department, was \$8.5 million. Despite increasing space and budget constraints, especially for clinical research activities, the Research Institute continues to pursue its mission according to the highest standards.

## EXTERNAL FUNDING RESULTS

**Dr. Geneviève Bernard** has received a Junior 1 Chercheur-boursier clinicien career award and an establishment grant from the Fonds de recherche-Santé Québec (FRQS) in support of her research entitled "*Caractérisation clinique et génétique de maladies neurodégénératives de l'enfant avec focus sur les leucodystrophies et maladies héréditaires de la matière blanche cérébrale.*"

**Dr. Evelyn Constantin** has received a Junior 2 *Chercheur-boursier clinicien* career award from the FRQS in support of her research entitled "*Troubles du sommeil chez les enfants: Les effets du traitement sur les résultats de santé.*"

**Dr. Sam Daniel** has received a grant of \$239,476 from the Canadian Institutes of Health Research (CIHR) over a three-year term for a project entitled "Multicenter pilot study on assessment and prevention of platinum-induced ototoxicity."

**Dr. Isabelle Gagnon** has received a Junior 2 *Chercheur-boursier clinicien* career award from the FRQS. In addition, the FRQS has awarded Dr. Gagnon a clinical research grant of \$215,255 over a three-year term in support of the project "*Évaluation de l'impact d'une intervention de réadaptation et le risque de subir une deuxième blessure chez les enfants et adolescents ayant subi une entorse de la cheville: étude clinique randomisée.*"

**Dr. Cindy Goodyer** has received funding from the Canadian Institutes of Health Research (CIHR) to study "The human growth hormone receptor: regulation of expression during development." Valued at \$629,130 over a five-year term, this grant was ranked first by the Endocrinology Committee at the CIHR.

**Dr. Paul Goodyer** has been awarded a grant of \$709,705 over a five-year term from the CIHR to study "Renal progenitor cells in kidney development and the response to renal injury."

**Dr. Lily Hechtman**, in collaboration with co-investigators Drs. Nathalie Grizenko, William Harvey and Ridha Joobar of McGill University, has received a grant of \$968,219 from the CIHR for a term of five years in support of "Efficacy of careful medication and tailored case management follow up treatment for children with attention deficit hyperactivity disorder."

**Dr. Nada Jabado** has received a Senior *Chercheur-boursier clinicien* career award from the FRQS in support of her research entitled "*Identification d'événements moléculaires et génétiques impliqués dans la genèse des astrocytomes de l'enfant.*" Dr Jabado's application for this award ranked first in the senior *chercheur-clinicien* fundamental research competition.

**Dr. Pierre Lachapelle**, in collaboration with co-principal investigator Dr. Sylvain Chemtob of the CHU Sainte-Justine, has received \$573,183 from the CIHR for a five-year term in support of "Oxygen and brain injury in the newborn: unprecedented role for fatty acid receptors and characterization of potential therapeutics."

**Dr. Larry Lands** has received a grant of \$152,329 over a two-year term from Cystic Fibrosis Canada to investigate "Activation of the type 1 interferon pathway in CF airway epithelial cells and macrophages to limit rhinoviral infections."

**Dr. Annette Majnemer**, in collaboration with Principal Investigator Dr. Adam Kirton of the University of Calgary and several colleagues from the universities of Calgary, Edmonton and Toronto, has been awarded a three-year grant of \$270,000 by the Heart and Stroke Foundation for the study entitled "Enhancement of developmental motor plasticity in perinatal stroke with transcranial direct-current stimulation."

**Dr. Bruce Mazer** received a grant of \$172,467 from AllerGen for a two-year term in support of "Disease modulation clinical tolerance study."

**Dr. Meranda Nakhla** has received a Junior 1 *Chercheur-boursier clinicien* career award and an establishment grant from the FRQS in support of her research programme "*Accessibilité aux soins de santé, utilisation des ressources et leur impact sur la santé des enfants et adolescents atteints de diabète au Québec.*"

**Dr. Maryam Oskoui** has received a New Investigator Grant from the CIHR/SickKids Foundation entitled: "Prevalence and Health Care Utilization Pattern of Children with Cerebral Palsy in Quebec. The grant is a three-year term which value is to be confirmed.

In addition, Dr. Wintermark has received a grant of \$300,000 for a three-year term from the Hospital for SickKids Foundation in support of her project entitled "Early identification of asphyxiated newborns at risk of developing significant brain injury despite hypothermia treatment."

## TEACHING & LEARNING

### UNDERGRADUATE MEDICAL STUDENTS

Under the excellent leadership of Dr. Preetha Krishnamoorthy, the Department of Pediatrics continues to give 2 major courses to the undergraduate medical students. Drs. Najma Ahmed and Giosi DiMeglio coordinate the Introduction to Pediatrics course which is a pre-clerkship course of 24 hours duration consisting of didactic lectures and small-group tutorials. The course is well received by students. However, this course is very labour-intensive and full-time faculty commit significant hours to ensure the success of the small groups. The Clerkship runs for eight weeks. The CTU's have historically been excellent clinical experiences for students. They provide an educational experience that challenges the students, while allowing them to perfect their clinical skills and be intimately involved in the care of ill children. The two-week neonatal unit experience provides an academic environment with hands-on practical experience and extended nursery exposure to both normal and ill newborns. The two weeks in the ambulatory area has the potential to be good but the experience is very "faculty supervisor" determined. The ER provides a wealth of clinical material, but having a student present increases the clinical load for the faculty. Some faculty deal with this better than others resulting in variable experiences for the students. There is a considerable amount of teaching given during the ambulatory two weeks.

The increasing class size is a major issue because the ward CTU's already have too many students for available commitment. We are actively exploring other clinical opportunities external to the MCH for the students, but there are not many opportunities at present.

Some students continue to do a one-month rotation in Val d'Or with three of our affiliated pediatricians. By and large, this has been an excellent experience. In addition, we have created an affiliated CTU on the hematology-oncology ward and on the Adolescent Medicine Services in order to be able to absorb some of the increase in student numbers. To date this is working very well.

In 2012, **Dr. Krishnamoorthy** was the recipient of the 2012 Osler Award from the School of Medicine's graduating class for outstanding teaching.

### **PEDIATRIC RESIDENCY TRAINING PROGRAM**

The pediatric Residency Training Program has a superb group of residents and teaching faculty, under the direction of Dr. Richard Gosselin, working well together to achieve their goals over the past year. Our most significant administrative achievement this past academic year has been extended preparations & self-study reflections for the Royal College Accreditation Site visit in March 2013.

We are also actively engaged in planning a Pediatric Simulation Centre on the MCH site that will both enhance simulation extraction and foster inter-professional cooperation.

After a gradual increase in resident numbers in the past 4 years (going to 12-13 incoming residents each year, compared to 10 in previous years), the number of RAMQ funded positions will start to come down significantly starting in July 2014, going from 8 to 6 CaRMS positions. This, in addition to competing duties and resident responsibilities such as participation in Protected Teaching activities and Residents Continuity Clinics, an increased number of off-site rotations, as well as significant changes in residents' contractual duty hour regulations, will require inpatient services, as well as others, to rethink the organization of clinical work and the distribution of clinical responsibilities. Already, we have taken note of a major impact on staff and allied health professional workloads, particularly in acute care units.

Innovations from the past 2 years have been consolidated: Complex Care and Medical Day Hospital rotations as well as our joint Pediatric Resident Research Day organized in collaboration with the Université de Montréal.

A significant remaining challenge remains monitoring the status of working environments, in particular of acute care areas. We will also need to pay closer attention to a better definition and implementation of policies regarding resident's safety.

In addition to the core number of about 45 Pediatric Residents, the Department is responsible for the Pediatric training of some 300 and more residents from other disciplines including Dermatology, Anesthesia, Family Medicine, Emergency Medicine, Family Medicine-Emergency Medicine, Radiology, Psychiatry, as well as Pediatric residents from other programs attracted to McGill University for electives who come for short cycle rotations. Each type of trainee has educational objectives that are specific to their particular discipline.

### **FELLOWSHIP TRAINING PROGRAMS**

Given our mandate to train academic pediatricians with specialized expertise, the Fellowship Training Programs within each specialty are very important. In 2012, the MCH Research Institute had a total of 15 externally funded scholars and 21 Post-Doctoral Fellows. The total number of fellowship trainees in Pediatric Medicine has been decreasing over the past several years we continue to have difficulties accommodating out of province fellowship candidates as funding for them via the RAMQ is contingent upon quotas (Canadian Transfer Quota). These constraints, plus government restrictions related to the number of approved staff positions for each hospital centre, contribute to a lack of growth in fellowship trainees. The trend over the past years has been a diminution in Quebec students doing specialty training, and a dramatic increase in International Medical Graduates (IMG's) that require non-Provincial funding.

Our international commitment to the training of first-rate academic candidates is evidenced by the Alan Ross Academic Fellowships supported through an endowment held for the Department of Pediatrics at McGill, which provides support for two fellows annually. The Clinical Fellowship program is supported by donations from clinical earnings of all members of the Department and supports on average three fellows per year. In 2012, there was one Ross fellowship funded and four Clinical Fellowships funded as follows: Dr. Chatchay Prempunpong – Neonatology, Dr. Selma Jade Torronen – Pediatric Nephrology, Dr. Joanna Merckx – Infectious Diseases, Dr. Yarden Yanishevsky – Pediatric Allergy & Immunology and Dr. Nadine Korah – General Pediatrics.

### **GRADUATE STUDENTS**

There is no graduate degree program in Pediatrics. There are 104 students enrolled in the MCH Research Institute, there are 21 supervisors from the Department who are cross-appointed in other faculties or Departments. These MCH Research Trainees 2012 consist of 51 M.Sc. and 53 Ph.D. students. Funding for these students is derived from external agencies and the internal studentship award program

## MILESTONES

The restrictions placed on foreign medical graduates, as well as continued budgetary deficits and critical lack of resources in the teaching hospital milieu, also significantly impact upon our ability to recruit the best international candidates. Our clinical income pool provides the majority of the total income for all Paediatricians and Pediatric specialists in the Department. The total base budget allocation from the Faculty remains unchanged from 2011. Despite this, the Department has been able to secure to total amount of 111 new staff appointments over the past decade in the following categories:
