INTERNATIONAL SECURITY: CONFLICT AND COOPERATION

This seminar will cover a broad array of theoretical and historical literature on conflict, strategy, war, and cooperation. We will discuss the key explanations for both systemic and regional conflicts and will address the question: how does cooperation evolve among states in an anarchic international system? The course will include structural, societal, and psychological explanations of war. Strategies of war and peace, including deterrence, the impact of nuclear revolution and the dynamics of nuclear proliferation form the other core parts of the course. We will also cover the topic of change in international politics, especially at the global and regional levels.

Requirements

Students are expected to write a substantive research paper (maximum 25 double-spaced pages for MA and 30 double-spaced pages or PhD students- inclusive of bibliography and footnotes) dealing with: (a) an application of one or more of the theories discussed to a significant event in international relations (e.g. crisis, war, or an event that resulted in a peace settlement or cooperation), or (b), explaining one of the above questions, using one's own theory, or (c) explaining a puzzle or a paradox in the realm of international conflict or cooperation. A one-page outline of the paper should be distributed among the participants beginning from the third week, and the seminar will discuss each of the research topics individually. The proposal should discuss the research question, possible alternative hypotheses, your own hypothesis or argument, methodology, theoretical and policy implications, and conclusions. All papers should conform to Chicago style footnotes and bibliography. In addition, each student is expected to make oral presentations on the basis of the required readings for the week. The deadline for paper submission is November 30, 2023.
