

REPORT 3 FROM ENROLMENT SERVICES (ES) TO SCTP [2016-2017]

SCTP meeting date: November 10, 2016

The following course and program proposals have been approved by Fiona Lees, Enrolment Services, on behalf of SCTP. Highlighted text in pink are queries to/information for units.

Minor and Moderate Revisions

Faculty of Education

B.Ed. in Kindergarten and Elementary Education; First Nations and Inuit Studies (120 cr.) – description, required courses added, required courses deleted, title revised for some required courses, required credits increased, a complementary course deleted, complementary courses added, title revised for some complementary courses, how complementary courses chosen revised, complementary credits decreased. *Rationale:* Updates to courses to create a more grounded program and correction to description. *SCTP Comments/Corrections:* As per Department, keep EDEC 342 and EDEC 344 in list of required courses – adjust credits accordingly.

B.Ed. in Teaching English as a Second Language – TESL Elementary and Secondary (120 cr.) – description, required course added, required credits increased, complementary courses deleted, how complementary courses chosen revised, complementary credit decreased. *Rationale:* Updates to courses to and correction to description. *ES Comments/Corrections:* What is the effective term - 201701?

B.Ed. in Teaching English as a Second Language – TESL Elementary and Secondary; Teaching Greek Language and Culture (120 cr.) – description, required course added, required credits increased, complementary courses deleted, how complementary courses chosen revised, complementary credit decreased. *Rationale:* Updates to courses to and correction to description. *ES Comments/Corrections:* Last paragraph of description revised [as per rationale] to read “.. professional e-portfolios throughout ...”; complementary credits revised to read “33” – both overall credits and within the first sentence listed under Complementary Courses heading.

Graduate and Postdoctoral Studies

M.Sc. in Parasitology (45 cr.) – program credit weight decreased, a required course deleted, credit weight increased for required thesis courses, required credits decreased. *Rationale:* Updates to courses to bring the program credit weight in-line with other thesis programs.

Ph.D. in Parasitology (0 cr.) – a required course deleted, a required course added, program note revised. *Rationale:* Updates to courses to bring the program into line with McGill standards.

M.Eng. in Civil Engineering; Non-Thesis (45 cr.) – description, a required course added, required credits increased, complementary courses added, how complementary courses chosen revised, complementary credits decreased.

Rationale: The minimum research content ensures that students have adequate training.
