B.A.; Concentration majeure en Langue et littérature françaises; Traduction (36 cr.) – program description, alternate/equivalent required courses added, how required courses chosen specified, title revised for a required course, streams added to complementary courses, title revised for some complementary courses, complementary courses added, how complementary courses chosen revised, course list headings revised. *Rationale:* Program description better reflects focus of program; and update to courses and listing of equivalent CCTR courses to provide students with more choice.

For information ...” – Department should verify that wording in the eCalendar is accurate.

B.Ed. in Secondary Mathematics (120 cr.) – program description, a required course added, required credits increased, complementary courses deleted, how complementary courses chosen revised, complementary credits decreased.

Rationale: Updates to courses. *SCTP Comments/Corrections:* Revise description to be consistent with listing of the Quebec Ministry of Education – recommend using same wording as in Secondary English and other B.Ed. programs.

Graduate Certificate in Surgical Innovation (15 cr.) – a required course deleted, required credits decreased, elective-course section added, how elective courses to be chosen revised, elective credits increased. *Rationale:* Provide more flexibility to students by adding an elective-course section.

Graduate Diploma in Surgical Innovation (30 cr.) – a required course deleted, required credits decreased, how complementary credits chosen indicated, how elective courses chosen revised, elective credits increased. *Rationale:* Provide more flexibility to students.

M.Sc. in Family Medicine (45 cr.) – a required course deleted, a required course added, required credits decreased, complementary courses deleted, complementary-course section deleted, complementary credits decreased, elective-course section added, how elective courses to be chosen indicated, elective credits increased. *Rationale:* Change an ever-growing complementary course list to a non-specific elective section to provide students with more flexibility.

M.Sc. in Family Medicine; Bioethics (45 cr.) – a required course deleted, a required course added, required credits decreased, how elective courses to be chosen revised, elective credits increased. *Rationale:* More relevant content for this program, and increase to elective credits will provide students with a bit more flexibility.

M.Sc. in Family Medicine; Medical Education (45 cr.) – program description, a required course deleted, a required course added, required credits decreased, complementary courses deleted, complementary-course section deleted, complementary credits decreased, how elective courses chosen revised, elective credits increased. *Rationale:* Provide students with more flexibility.
