B.A.; Joint Honours - Economics Component (30 cr.) – description, program requirements text revised. *Rationale:* Revisions to requirements will make the rules clearer and more explicit. *ES Comments/Corrections:* Revise added text by spelling out “Supp” and indicate “exam” where appropriate; correct required-course credits to read “27”; correct complementary-course credits to read “3”; correct course titles for ECON 450 and ECON 452;

B.A.; Joint Honours in Economics and Accounting (60 cr.) – description, program requirements text revised. *Rationale:* Revisions to requirements will make the rules clearer and more explicit. *ES Comments/Corrections:* Revise added text by spelling out “Supp” and indicate “exam” where appropriate; correct course titles for ECON 450 and ECON 452;

B.A.; Joint Honours in Economics and Finance (60 cr.) – description, program requirements text revised. *Rationale:* Revisions to requirements will make the rules clearer and more explicit. *ES Comments/Corrections:* Revise added text by spelling out “Supp” and indicate “exam” where appropriate; correct course titles for ECON 450 and ECON 452.

Because revisions to CACC 220 has the program corequisite as a true prerequisite, i.e., program corequisite must be taken before CACC 220.

B.Eng. in Chemical Engineering (142-145 cr.) – complementary course deleted, complementary courses added, how complementary courses to be chosen revised, list headings added to complementary courses, note revised. *Rationale:* To address the issues students have registering for certain courses.

Otherwise, these credits need to be indicated;

B.Eng. in Electrical Engineering (134-139 cr.) – minimum program credit weight decreased, a Freshman required course deleted, required courses deleted, required courses added, required-course credits decreased, a required-course note deleted, complementary courses deleted, complementary courses added, how complementary courses chosen revised, complementary-course credits increased. *Rationale:* To update, modernize, and restructure the program. **ES**

Comments/Corrections: Indicate Complementary Courses as “29-34 credits”; under Group B indicate “OR 3 credits from the following.”; should “OR” be indicated before Language Courses, as this section seems to be considered part of Group B? Otherwise, these credits need to be indicated;

B.Eng.; Honours in Electrical Engineering (138-140 cr.) - program credit weight maximum increased, a Freshman required course deleted, required courses deleted, required courses added, required-course credits decreased, a required-course note deleted, complementary courses deleted, complementary courses added, how complementary courses chosen revised, complementary-course credits increased. *Rationale:* To update, modernize, and restructure the program. **ES**

Comments/Corrections: Indicate Complementary Courses as “29-31 credits”; revise Technical Complementaries breakdown to read “3-4 credits (1 course) ...” and “6-7 credits (2 courses) from List C ...”; under Group B indicate “OR 3 credits from the following.”; should “OR” be indicated before Language Courses, as this section seems to be considered part of Group B? Otherwise, these credits need to be indicated;

B.S.E. (137-144 cr.) - a Freshman required course deleted, required courses deleted, required courses added, required-course credits decreased, a required-course note deleted, complementary courses deleted, complementary courses added, how complementary courses chosen revised, complementary-course credits increased. *Rationale:* To update, modernize, and restructure the program. **ES**

Comments/Corrections: Correct program credit weight for out-of-province students; indicate Complementary Courses as “21-28 credits”; under Group B indicate “OR 3 credits from the following.”; should “OR” be indicated before Language Courses, as this section seems to be considered part of Group B? Otherwise, these credits need to be indicated;

M.U.P.; Non-Thesis (66 cr.) – description, a required course’s title revised, complementary courses deleted, complementary courses added, a complementary course’s title revised, complementary-course credits increased, how complementary courses chosen revised, groups added to complementary courses, and elective-course credits decreased. *Rationale:* To clearly indicate a research component, and provide a wider range of courses.
