The following course and program proposals have been approved by Associate Provost Chris Buddle, SCTP Chair, on behalf of SCTP. **Highlighted entries in pink are queries to/information for units.**

Minor and Moderate Revisions

School of Continuing Studies

Certificate in Proficiency in French Language and Culture (120 CEUs) – program title, title revised for the required courses. *Secretary's comments/corrections:* Add the following sentence to the rationale: “Via this proposal, the existing Certificate in Proficiency in French Language and Culture (Intensive) is being retired”; correct program title in the existing column in box 7.0; use strikethrough in the existing column only on the course title – the entire course is not being removed; use underlining in the proposed column only on each of the course titles.

B.Sc.; Honours in Microbiology and Immunology (72 cr.) – alternate required courses deleted, required-course note revised, required credits increased, how complementary courses chosen revised, complementary credits decreased.

Secretary's comments/corrections: Effective term revised to 202201.

B.Sc.; Liberal Program – Core Science Component in Physiology (47 cr.) – program credit weight decreased, required courses deleted, required credits decreased, complementary courses added, how complementary courses chosen revised, complementary credits increased. *Secretary's comments/corrections:* This program does not have a program description within the eCalendar – consider proposing one in the near future; effective term revised to 202201.

B.Sc.; Major in Physiology (61-62 cr.) – program credit weight decreased, program description, required courses deleted, required credits decreased, complementary courses added, how complementary courses chosen revised, complementary credits increased. *Secretary's comments/corrections:* Correct existing and proposed program credit weight within the proposal; revise program description to indicate revised program credit weight and remove CHEM 212 from description – if some students need this course, then add it the list of complementary courses as “0-3 credits from: CHEM 212 ...” and adjust credits accordingly; effective term revised to 202201.

B.Sc.; Honours in Physics (78 cr.) – a required course deleted, required credits decreased, a complementary course added, how complementary courses chosen revised, complementary credits increased. *Secretary's comments/corrections:* Correct existing and proposed requirements to include omitted heading “U3 Complementary Courses (21 credits)””; effective term revised to 202201.

YCBS 279 Digital Platforms&EmergTechnos (3 CEUs). *Chair's comments/corrections:* Confirmation needed as to why the rationale indicates this new course is required for a new program that has not been proposed to SCTP for approval, and confirmation needed as to which students will take this course if no program exists. *Secretary's comments/corrections:* Title abbreviation revised; revise supplementary information to be consistent – change “+” to “plus”; revise effective term to 842201 or 842209;

YCBS 280 Digital Prod Dev Capstone Proj (6 CEUs). *Chair's comments/corrections:* Confirmation needed as to why the rationale indicates this new course is required for a new program that has not been proposed to SCTP for approval, and confirmation needed as to which students will take this course if no program exists. *Secretary's comments/corrections:* Title abbreviation revised; be consistent with the supplementary information - spell out “+” to read “plus”; revise effective term to 842201 or 842209.

EDGC 398 **Intern: Educ in Global Contexts** (0 cr.) [PRN 19740]. Affected program indicated. *Chair's comments/corrections:* Following discussion between Professor Joseph Levitan and staff from the Office of the Associate Provost (Teaching and Academic Programs) [Ms. Julie Degans and Ms. Cindy Smith], it was agreed that this new course would have EDGC 299 as the prerequisite, EDGC 399 would have EDGC 398 as the prerequisite, and the course titles would remain as they were originally proposed [see Report from April 7, 20216]; some course titles were reported differently to the CPU – “Co-op” instead of “Internship”, but Professor Levitan confirmed that “Internship” would be more appropriate for this new course. *Secretary's comments/corrections:* Indicate full program title for affected program; title abbreviation revised; confirmation is needed whether there is an approver at the offering unit level for this course – this is important to trace who proposed this course for the offering unit.
