The following course and program proposals have been approved by Associate Provost Chris Buddle, SCTP Chair, on behalf of SCTP. **Highlighted text in pink are queries to/information for units.**

Minor and Moderate Revisions

Faculty of Arts

M.A. in Economics; Non-Thesis (45 cr.) – a required course added, required credits increased, complementary courses deleted, how complementary courses chosen revised, complementary credits decreased.

M.A. in Economics; Non-Thesis – Population Dynamics (45 cr.) – a required course added, required credits increased, complementary courses deleted, how complementary courses chosen revised, complementary credits decreased. *Secretary's comments/corrections:* Confirmation needed whether students must choose 3 credits exclusively from that last list of complementary courses – if so, revise it to simply read “3 credits from the following (a course in the same/approved field, chosen in consultation with the student's supervisor):” - if students may only choose from that specific list, there is no need to refer to the excluded courses or at 500 level or higher.

M.A. in Economics; Non-Thesis – Development Studies (45 cr.) – a required course added, required credits increased, complementary courses deleted, how complementary courses chosen revised, complementary credits decreased.

Faculty of Medicine and Health Sciences

Ph.D. in Biochemistry (0 cr.) – program description, single-term required course replaced by spanned versions of the same course, required-course notes revised, how complementary courses chosen revised, complementary-course note revised. *Secretary's comments/corrections:* Revise effective term to “202309”; provide rationales for all changes; if the second group of complementary courses is “0-3 credits”, then revise first group of complementary-course credits to read “3-6”; revise last sentence of the revised complementary-course note to read “... These additional courses are not ...”

Ph.D. in Biochemistry; Bioinformatics (0 cr.) – program description, single-term required course replaced by spanned versions of the same course, a required course deleted, a required course added, required-course notes revised, complementary-course note revised. *Chair's comments/corrections:* Confirmation needed whether there was any follow-up to the comments made in the consultation from Dr. Greenwood concerning lectures to be attended by students in this program. *Secretary's comments/corrections:* Revise effective term to “202309”; correct existing description to read “None”; revise last sentence of the revised complementary-course note to read “... These additional courses are not ...”

M.Sc. in Biochemistry (45 cr.) – program description, single-term required course replaced by spanned versions of the same course, required-course note added, how complementary courses chosen revised, complementary-course note revised. *Secretary's comments/corrections:* Revise effective term to “202309”; provide rationales for all changes; move the note referring to BIOC 696D1/D2 to follow the list of required courses; revise last sentence of the revised complementary-course note to read “... These additional courses are not ...”
