**B.A.; Honours in Urban Studies** (60 cr.) – program description, program notes deleted, required courses deleted, required credits decreased, complementary-course subheadings added, complementary courses deleted, complementary courses added, some complementary courses moved from one group to another, how complementary courses chosen revised, complementary credits increased. *Secretary's comments/corrections:* Delete third sentence from first paragraph of revised program description.

**B.A.; Major Concentration in Geography; Urban Studies** (36 cr.) – program description, a complementary-course subheading added, a program note deleted, complementary courses deleted, complementary courses added, how complementary courses chosen revised. *Secretary's comments/corrections:* Delete third sentence from first paragraph of revised program description.

**B.A.; Minor Concentration in Geography; Urban Studies** (18 cr.) – program description, required-course section added, a required course added, required credits increased, complementary-course subheadings added, complementary courses deleted, complementary courses added, how complementary courses chosen revised, complementary credits decreased. *Secretary's comments/corrections:* Revise proposed description to read “This ... interdisciplinary program that is an introduction to a range of ... world. Students should observe ...” – delete third sentence from revised program description.

**B.A.; Joint Honours – Religious Studies Component** (36 cr.) – program description, a required course deleted, a required course added, complementary courses added, some complementary courses moved from one group to another, how complementary courses chosen revised. *Secretary's comments/corrections:* Revise effective term to 202309.

**B.A. & Sc. Degree Requirements** – multitrack and joint honours programs text revised - BASC 201 becomes required for students in these programs, interfaculty and honours programs text revised - BASC 201 becomes recommended for students in these programs, course requirements text revised.

**B.A. & Sc.; Honours in Sustainability, Science, and Society** (60 cr.) – program description, required courses added, how required courses chosen deleted, complementary courses deleted, complementary courses added, a complementary-course subheading deleted, a complementary-course subheading added, how complementary courses chosen revised, an asterisk added to some complementary courses, a program note added, how complementary courses chosen revised. *Secretary's comments/corrections:* Confirmation needed as to whether all students that take ENVR 495 must pass the course with a grade of B or if it just applies to students in this program [as per program description]; use underlining on all revised text/added courses in proposed column.

Practitioner focuses on the multifaceted ... settings, including advanced assessment ... practitioner. Students who complete ...”

**Graduate Diploma in Neonatal Nurse Practitioner** (30 cr.) – program description, required courses deleted, required courses added, title revised for a required course, credit weight revised for a required course. *Secretary's comments/corrections:* Revise description to read “The ... or the Graduate Certificate in ... Master's in Nursing) focuses on the multifaceted ... settings, including advanced assessment ... scope of practice. Students who complete ...”

**M.Sc.(Applied) in Advanced Nursing; Non-Thesis – Advanced Practice Nursing** (48 cr.) – program title – concentration/option added, program description, required courses deleted, required courses added, title revised for some required courses, required credits decreased, streams added to complementary courses, complementary courses added, how complementary course chosen revised, complementary credits increased. *Secretary's comments/corrections:* Revise description to read “The ... or the Graduate Certificate in ... Master's in Nursing) focuses on the multifaceted ... settings, including advanced assessment ... scope of practice. Students who complete ...”; revise the streams to indicate “9-12 credits from one of the following streams, remove 3-6 credits for NUR2 622 and NUR 628, as all students need to take these credits, and remove from the streams 3 credits in the area of Health Equity and the 0-3 credits Advanced Practice Nursing, as all students need to take these also; fix the course numbers as there are more than one course per line.

~~**M.Sc.(Applied) in Nursing; Non-Thesis—Global Health Direct Entry (61 cr.); WITHDRAWN – existing description and program requirements are incorrect [see revised proposal from May 3, 2018 for last revisions].**~~

**M.Sc.(Applied) in Nursing; Non-Thesis – Direct Entry to Advanced Practice Nursing** (61 cr.) – program concentration/option title added, programs description, required courses deleted, title revised for a required course, required credits decreased, complementary-course section added, streams added to complementary course, complementary courses added, how complementary courses chosen indicated, complementary credits increased. *Secretary's comments/corrections:* Correct program title in revised description; revise description to read “The ... program focuses on the preparation needed for both entry-to-practice and advanced practice nursing. A ... approach is used in a variety of clinical settings. Emphasis is placed ... practice. Clinically relevant nursing challenges will be addressed in one of the two streams. Graduate of this program are eligible to write the OIIQ licensing exam. ”; the wrong program title is indicated in the sentence related to the qualifying year; move the Qualifying Year under Program Prerequisites within the program requirements; indicate before the Knowledge stream “12 credits from one of the following two streams”; underline all text within complementary-course section as all are additions.

**M.Sc.(Applied) in Advanced Nursing; Non-Thesis – Global Health** (48 cr.) – program description, required courses deleted, required courses added, title revised for some required courses, how complementary credits chosen revised. *Secretary's comments/corrections:* Revise description to read “The ... this work. This program emphasizes health equity focus content throughout the program. In the final year of study, the program includes one semester in a global ... internationally) that focuses on clinical and project-based work”; correct title for NUR2 617 – course revision proposal withdrawn because a course revision/retirement for NUR 618 was not concurrently submitted;

The program focuses on the basic health sciences foundations” – delete text about courses and access to the professional program; use strikethrough on all text being revised/removed; use underlining on all text being revised/added; correct course title for added course – see New Course section below; remove “the following” from the sports practicum sentence, as there are no courses listed – revise to read “Student may take 3 credits of Sports Medicine Practicum courses (selection interview ...”; add the IPEA courses to the beginning of the list of required courses – these are listed in alphabetical order by subject code;

**B.Sc.(Rehab.Sc.); Major in Physical Therapy** (90 cr.) – program description, a required course added, required credits increased, required interprofessional education activities text deleted, required courses grouped together, how complementary courses chosen revised, complementary credits decreased. *Secretary's comments/corrections:* Correct the administering faculty to read “Medicine and Health Sciences”; revise the effective term to 202301; revise description to read “The B.Sc.(Rehab.Sc.); Major in Physical Therapy emphasizes clinical reasoning ... therapist. The program focuses on the basic health sciences foundations,” – delete text about access to the Master's program; use strikethrough on all text being revised/removed; use underlining on all text being revised/added; correct course title for added course – see New Course section below; revise the sports medicine practicum text to read “Students may take PHTH 301 Sports Medicine Practicum (3 credits) as a complementary course in U2; add the IPEA courses to the beginning of the list of required courses – these are listed in alphabetical order by subject code;

**B.Sc.; Honours in Pharmacology** (76 cr.) – complementary courses added, a program note added. *Secretary's comments/corrections:* Revise added note to read “If chosen, PHAR ...”

**B.Sc.; Major in Pharmacology** (67 cr.) – complementary courses added, double-circumflex symbol added to some complementary courses, a program note revised and grouped together with other notes, a program note added.

*Secretary's comments/corrections:* Move note concerning PHAR 599D1/D2 to “Note” section and revise to read: “^If chosen, PHAR 599D1 and PHAR 599D2 ...”; revise added note to read “^If chosen, PHAR ...”

**B.Sc.; Major in Psychology** (54 cr.) – background text revised, program prerequisites added, a program note added, complementary-course subheadings revised, a complementary-course subheading added, complementary courses added, how complementary courses chosen revised. *Secretary's comments/corrections:* Propose a program description, as what is indicated is not sufficient; indicate BIOL 111, BIOL 112, and PSYC 100 as program prerequisites, otherwise these credits count towards the program credit weight and this will need to be revised; indicate number of prerequisite credits to be taken “0-9 credits” – this is not clear; indicate PSYC 204 as a program prerequisite/corequisite, otherwise its credits are to be added to required credits and this affects the overall program credit weight.

**B.Sc.; Liberal Program – Core Science Component in Psychology** (45 cr.) – background text revised, program prerequisites added, a program note added, complementary-course subheadings revised, a complementary-course subheading added, complementary courses added, how complementary courses chosen revised. *Secretary's comments/corrections:* Propose a program description, as what is indicated is not sufficient; indicate BIOL 111, BIOL 112, and PSYC 100 as program prerequisites, otherwise these credits count towards the program credit weight and this will need to be revised; indicate number of prerequisite credits to be taken “0-9 credits” – this is not clear.

**B.Sc.; Minor in Psychology** (24 cr.) – recommended background text added and a course added to this text, how complementary courses chosen revised. *Secretary's comments/corrections:* Correct program category in box 1.4 – this is not a Minor Concentration; confirmation needed for whether PSYC 204 is a program prerequisite – if not, add it to complementary courses as “0-3 credits from” and list PSYC 204 with note, and adjust other credits appropriately.

**B.Sc.; Minor in Field Studies** (18 cr.) – program text revised, required courses deleted, required courses added, complementary courses deleted, and how complementary courses chosen revised. *Chair's comments/corrections:* Confirmation needed whether the fee for the Barbados Field Study Semester will be revised; confirmation also needed whether the courses deleted from the program will be retired.

**Barbados Field Study Semester** (15 cr.) – program description, required courses deleted, required courses added, required credits increased, complementary courses deleted, complementary-course section deleted, complementary credits decreased. *Chair's comments/corrections:* Confirmation needed whether the fee for the Barbados Field Study Semester will be revised; confirmation also needed whether the courses deleted from the program will be retired; a program revision proposal is needed for the B.Eng.; Minor in Environmental Engineering because of how the courses are listed for this field study semester; remove referral to the B.Sc.(Ag.Env.Sc.); Minor in International Agriculture, as the courses for this field study semester are not specified; all other affected program information should be appended to the new course proposals and not the program revision proposal.

**B.Sc.; Major in Mathematics and Computer Science** (72 cr.) – program description, a required-course note added, asterisks added to a required course, **complementary courses specified**, how complementary courses chosen revised. *Chair's comments/corrections:* Propose a program description, as none currently exists within the program section of the eCalendar. *Secretary's comments/corrections:* Remove links for major and honours courses and list specific courses within the appropriate section of this program – all program requirements should be listed within the program, which is listed within the program section of the eCalendar, and students should not be directed elsewhere to see a program's requirements.

**B.Sc.; Honours in Probability and Statistics** (60-63 cr.) – program description, advising notes revised, advising notes added, program notes added, complementary courses added, **how complementary courses chosen revised**.

*Chair's comments/corrections:* Obtain a consultation from the School of Computer Science to add their courses.

*Secretary's comments/corrections:* Update the proposal as per updates made to the B.A. version.

**B.Sc.; Major in Physics (60-63 cr.) WITHDRAWN BY SCTP – changes seem to be in the April 20, 2023 submission.** *Chair's comments/corrections:* Propose a program description, as what is listed within the program section of the eCalendar is not sufficient; revise the rationale to provide an explanation as to why an honours thesis course is added to this major program. *Secretary's comments/corrections:* Correct the program credit weight in boxes 4.0 and in both existing and proposed columns of box 7.0; indicate the number of prerequisite credits needed and instead of number of courses, indicate the number of credits from the prerequisite groups; remove COMP 208 and the note relating to this and add it with PHYS 512 to the list of complementary courses as “3 credits from:” and list COMP 208 and PHYS 512 – adjust required and complementary courses accordingly; use strikethrough on all deleted text/courses in existing column; use underlining on all revised/added text in proposed column.
